
NARRATIVE TO COMPLY WITH O.R.S. 209.250

Purpose: To survey and monument Client's property pursuant to the 2004 State Ballot Measure 37, and Jackson County Commissioners Board Order Number 130-05, signed on March 30, 2005. Utilizing a Nikon DTM-520 Total Station and a Ranger 200-R Data Collector with TDS software, and a Trimble 5700 GPS receiver, with a TSCE Data Collector all found monuments, as depicted hereon, were tied in a closed loop traverse or with redundant ties.

Procedure: Based on said traverse, Surveys Numbered 3453, 11096, 11183 and 16486 all as filed in the Jackson County Surveyor's Office, Jackson County Roads Roll Map records Map Númber 2/3 as filed in the office of the Jackson County Surveyor, Re-establish notes for government corners as found in the office of the Jackson County Surveyor and Document Numbers 00-01980 and 03-3330 of the Official Records of Jackson County, Oregon.

> Holding found monuments at the East and West One-Quarter corners of Section II the south boundary of the project was established as depicted hereon. Holding found monuments at the North One- Quarter corner and the Northwest corner of Section II the north boundary was established as depicted hereon. The east line of the project was established using standard section breakdwon practices to establish the WI/16 and the CW I/16 corners of said Section II as depicted hereon, found monuments per Survey Number 16486 were found at these computed positions. County Roads Records for Antioch Road (Map Number 2/3) and Survey Number 3453 were used to establish the right-of-way for Antioch Road. Monuments on the right-of-way of Antioch Road fit the record data per the Roll Map and Survey Number 3453 as depiced hereon. The monument called for at the intersection of Sweet Lane on 5N 9233 has since been overlayed and was not uncovered during this survey. The reference monument set on Survey Number 9233 was found to be 0.29 easterly of the calculated right-of-way. This monument was not held because it did not #> the found monuments per the road survey of Antioch Road (Roll Map 2/3).


