SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

PURPOSE:

TO SURVEY AND MONUMENT THIS PROPERTY LINE ADJUSTMENT PER CLIENTS REQUEST.

PROCEDURE:

UTILIZING GLOBAL POSITIONING SYSTEMS CONTROL ESTABLISHED IN THIS SURVEY, I TIED THE MONUMENTS AS SHOWN HEREON.
USING RECORD SURVEYS NUMBERED 1595 AND 16371, AS WELL THE PLAT OF J.J FRYER'S DIVISION OF EAGLE POINT, I ESTABLISHED THE LOT BOUNDARIES AS FOLLOWS:

THE FOUND MONUMENTATION ON THE EASTERLY AND SOUTHERLY BOUNDARIES WERE FOUND TO TO MATCH RECORD AND WERE HELD, I THEN EXTENDED THE BEARING OF THE SOUTHERLY BOUNDARY TO THE SOUTHWEST TO INTERSECT WITH RECORD BEARINGS AND DISTANCES OF THE NORTHERLY AND WESTERLY BLOCK 4 BOUNDARIES FROM THE ORIGINAL RETRACEMENT SURVEY OF BLOCK 4, SURVEY NO. 1595, THAT ORIGINATE FROM THE FOUND PIN AT THE NORTHEAST CORNER OF BLOCK 4, I THEN PROPORTIONED THE BLOCK INTO LOTS AS SHOWN HEREON. DUE TO THE RELATIVE MATCHING OF THE PLAT AND RECORD SURVEYS MENTIONED, NO ROTATION WAS APPLIED TO THIS SURVEY. THE TIED THOMAS PIN, LOCATED NEAR THE NORTHWEST CORNER OF BLOCK 4, IS SHOWN ON THE BARTLETT SUBDIVISION PLAT, VOLUME 13 PAGE 51 OF RECORDS, AS A FOUND MONUMENT AND NOT BEING SET BY THOMAS, AS A RESULT OF ITS QUESTIONABLE ORIGIN AND ITS CONFLICTING POSITION, THIS PIN WAS NOT HELD.
