
### DECLARATION

## SURVEYOR'S CERTIFICATE

I, Stephan L. Barott, a duly registered surveyor of the State of Oregon. do hereby certify that I have correctly surveyed and marked with the proper monuments as provided by law the tract of land hereon shown and the plat is a correct representation of the same, and the following is an accurate description of the boundary lines:

THE NORTHWEST ONE-QUARTER OF THE SOUTHEAST ONE-QUARTER OF SECTION 17, TOWNSHIP 35 SOUTH, RANGE 4 WEST, OF THE WILLAMETTE MERIDIAN. JACKSON COUNTY, OREGON

SURVEY NARRATIVE TO COMPLY WITH .R.S. 209.250

### **PURPOSE:**

To survey and monument my Client's property pursuant to Measure 37 Claim M37 2005-00074. Board of County Commissioneers of Jackson County Order No. 478-05 and recorded as Document 2005-057598, Jackson County, Oregon.

Order No. 478-05 authorizes my client to subdivide his entire 40 acres into 5 acre lots. At this time, only one 5 acre parcel will be partitioned. The remaining 35 acres will be one parcel, reserving the right to subdivide or partition in the future.

Prior to commencement of this survey an investigation was conducted of all surveys of record. The North and West lines of my client's property had been identified during surveys as noted on page 2 of this Partition

At the Center 1/4 and Center-East 1/16 corners iron pins without caps were found. At my clients request, I placed 2 ½-inch diameter aluminum caps on these found iron pins stamped with the aliquote part of Section 17 they represent.

My client's intent is to create a 5 acre parcel parallel to his North and East boundaries, holding the found monuments on the North. I established the Southeast 1/6 utilizing the survey control of Survey No. 12236, 7784, and 6860.

Having identified the exterior boundaries of the NW4SE4 of Section 17, I established the C-N-SE 1/4 at the southeast corner for parcel 2. From said 1/64 corner, I established the southeast corner for parcel 2 parallel to and at the same distance as the north line of parcel 2.

Equipment used include a Leica TCRP 1203 SMARTSTATION Electronic Total Station.
