## SURVEY NARRATIVE

PURPOSE: To survey and monument a 7 lot Subdivision as depicted hereon.

PROCEDURE: The boundary was established by holding found monuments from filed surveys 3454, 5918, 6674, 9240, 15320 and 15983. Fairfield Drive and Westmont Drive was dedicated to the public through Instrument number 70-10564 of the Official Records of Jackson County, Oregon. Westmont Drive was surveyed and a portion was monumented on filed survey number 3454. I found monuments set on filed survey number 3454 and held for them for the right of way of Westmont Drive. The Westerly right of way of Fairfield Drive was monumented on filed survey number 15983. 
