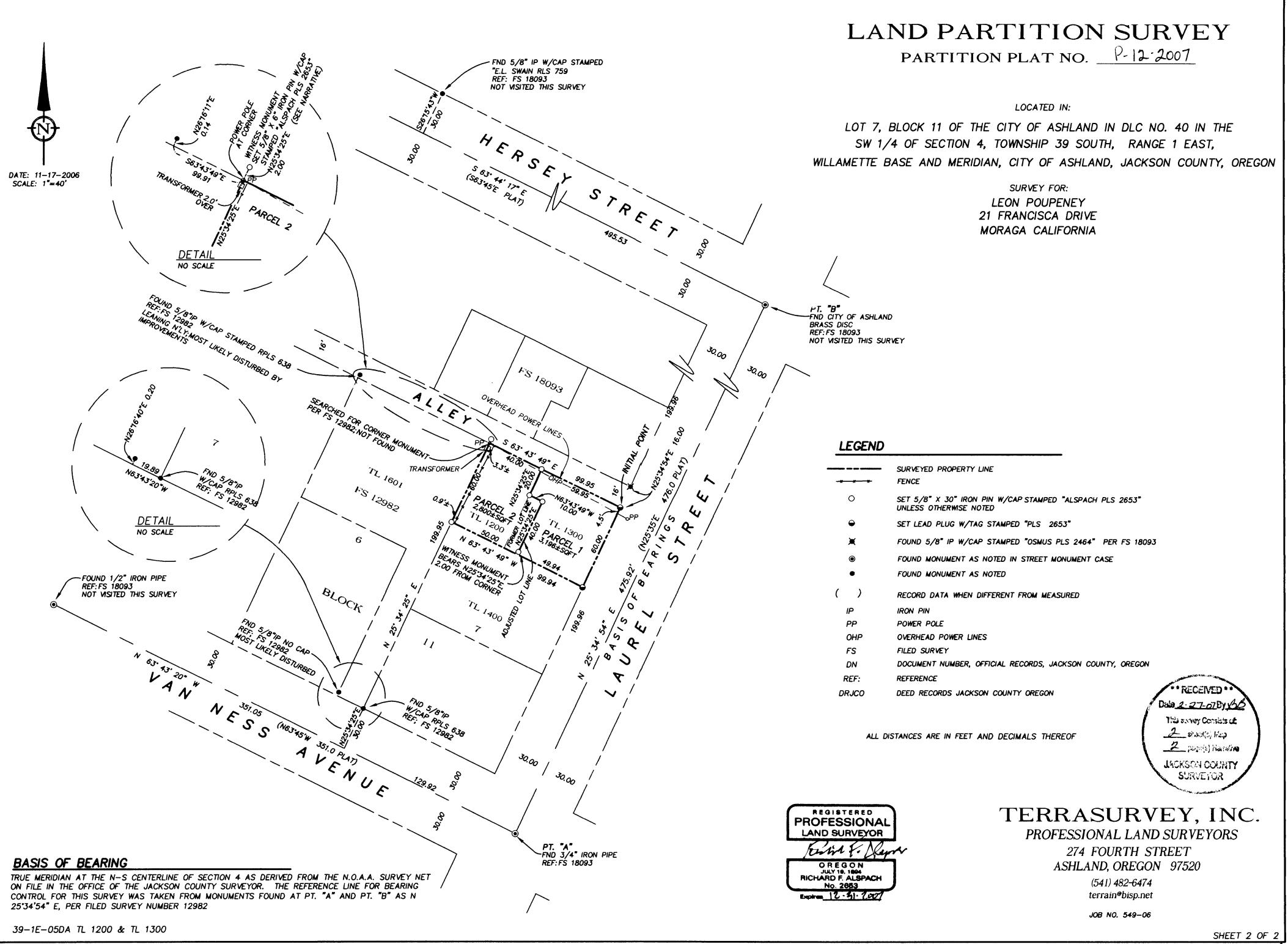

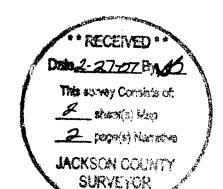
Located in Lot 7, Block 11, of the City of Ashland in DLC 40 in the SW 1/4 of Section 4, Township 39 South, Range 1 East, Willamette Meridian, City of Ashland, Jackson County, Oregon

PURPOSE:

The purpose of this survey is to monument and complete a property line adjustment between tax lot 1200 and tax lot 1300 (Assessor's Map No 39-1E-05 DA) per the approved planning action No. 2006-01893.

BASIS OF BEARINGS:

True Meridian at the N-S centerline of Section 4 as derived from the N.O.A.A. survey net on file in the office of the Jackson County Surveyor. The reference line for bearing control for this survey was taken from found centerline monuments on Laurel Street at Van Ness Avenue and at Hersey Street as N 25°34'54" E per Filed Survey No. 12982



PROCEDURE:

Using found control from a previous survey by this office (FS 18093) which had located pertinent street centerline monuments, I proceeded to search for and tie addition survey monuments in the subject area.

Block 11 of the 1888 Map of Ashland had been previously surveyed and proportioned by Filed Survey No. 8565 and subsequent surveys in the block have adopted and held that survey for the proportioned lines in that block. This survey has done the same. The block was proportioned along Laurel Street from found centerline monuments. The westerly line of lot 7 was determined by holding the found corner monument at the southwest corner of Lot 7 and record bearing from FS 12982. This procedure yielded a record distance along the northerly line lot 7 per FS 12982. Two other corner monuments from FS 12982 were found significantly off from record position as compared to other monuments found from the same survey and were deemed to be disturbed. One of the found monuments along the ally was leaning northerly and located immediately adjacent to a concrete garbage enclosure pad and fence post. The other monument along Van Ness Street had the plastic cap removed.

Two witness monuments were set out of necessity. The witness monument for the northwest corner of Parcel 2 is a 5/8" x 6" iron pin set in asphalt pavement and lies directly over marked underground power lines leading from a power pole which occupies the corner location. The southeast corner of Parcel 2 is occupied by the concrete footing of a 4"x4" fence post at the fence intersection.

The fence along the southerly line of Parcels 1 & 2 follows the property line as well as can be expected while the fence along the westerly line of Parcel 2 is obviously constructed off of the line as noted on the plat.
