## SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

PURPOSE: TO SURVEY AND MONUMENT THAT TRACT OF LAND DESCRIBED WITHIN INSTRUMENT NO. 2007-021548 OF THE OFFICIAL RECORDS OF JACKSON COUNTY, OREGON.

PROCEDURE: THIS SURVEY WAS CONDUCTED UTILIZING AN ELECTRONIC LEICA TCRA 1103 ROBOTIC TOTAL STATION AND RANGING PRISMS, WITH THE MONUMENTS SURVEYED AS SHOWN. THE SUBJECT PROPERTY LEGAL DESCRIPTION IS IDENTICAL TO WHAT IS SHOWN AS LOT 5 OF THE A.D.POWELL TRACTS, AN UN-RECORDED SUBDIVISION PERFORMED BY THE LATE SURVEYOR L.E. AGER, DATED APRIL 14, 1949, AND FILED AS SURVEY NO. 139 IN THE OFFICE OF THE JACKSON COUNTY SURVEYOR. THE PARENT PARCEL OF THE A.D. POWELL TRACTS AS SURVEYED BY AGER AND DESCRIBED IN VOLUME 314, PAGE 45 OF THE DEED RECORDS OF SAID COUNTY, CALLS OUT THE NORTHWEST CORNER OF THE SOUTH HALF OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 9 AS THE POINT OF BEGINNING. AGER FINDS AN HOLDS A TWO INCH IRON PIPE AT SAID CORNER THAT WAS ORIGINALLY SET BY M.L. McCALL ACCORDING TO CITY RECORDS, WHICH WAS ALSO ON THE CENTERLINE OF ALTAMONT STREET CREATED BY AND RETAINED FROM THE SINCE VACATED 1910 GRANDVIEW SUBDIVISION. THE TWO INCH PIPE AT SAID CORNER WAS LATER DETERMINED TO BE LOST OR DESTROYED. IN 1974, SURVEYOR EVERETT SWAIN SETS A NEW MONUMENT FOR SAID FRACTIONAL SECTION CORNER BY A PROPORTIONAL METHOD OF MEASUREMENT IN THE PERFORMANCE OF SURVEY NO. 5853, THE POSITION WHICH IS SOUTHERLY 4.66 FEET FROM THE MONUMENTED CENTERLINE OF ALTAMONT STREET. FOR THE PURPOSE OF THIS SURVEY, BEING A RETRACEMENT OF THE A.D. POWELL TRACTS, I HOLD THE RIGHT-OF-WAYS FOR ALTAMONT AND EUCLID STREETS AS MONUMENTED, BUT HOLD THE RECOVERED AGER LOT CORNERS FOR LOT SIDELINES, AS THEY BEST REPRESENT THE INTENT OF THE ORIGINAL SURVEY AND CONVEYANCES AND ARE IN HARMONY WITH THE EXISTING IMPROVEMENTS. THE ALLEY SHOWN ON THE AGER SURVEY, WAS CREATED AS A PRIVATE ROAD AS DESCRIBED WITHIN VOLUME 465. PAGE 25 OF SAID DEED RECORDS AND DETERMINED HEREON BY HOLDING THE RECOVERED 1 1/2" IRON PIPE AT THE SOUTHEAST CORNER OF LOT 5 OF THE A.D. POWELL TRACTS (VOLUME 348, PAGE 99 OF DEED RECORDS) AND HELD PARALLEL WITH THE CENTERLINE OF ALTAMONT STREET AS PER DEED RECORDS AS SHOWN ON SURVEY NO. 139. ORIGINAL MONUMENTS WERE DILIGENTLY SEARCHED FOR AT EVERY LOT CORNER ALONG BOTH SIDES OF THE ALLEY, BUT ONLY THE PIPES FOUND ON THE EAST SIDE OF THE ALLEY AS SHOWN WERE RECOVERED BUT DID NOT FIT WELL WITH THE DEED OR SURVEY RECORD TO HOLD FOR PROJECTING A BEARING WESTWARD TO THE CENTERLINE OF SECTION 9. THE SOUTHWEST CORNER OF THE SUBJECT PROPERTY WAS DETERMINED BY PROPORTIONAL MEASUREMENT BETWEEN THE 1 1/2" IRON PIPE AND THE EAST LINE OF THE 20 FOOT WIDE ALLEY PARALLEL WITH SAID SECTION CENTERLINE.
