

**SURVEY NARRATIVE**

PURPOSE: To survey the Westerly Deed line of instrument number 73-07855 of the Official Records of Jackson County, Oregon, as depicted hereon.

PROCEDURE: Utilizing control and monuments found and set from filed survey 14876 previously performed in 1995 by this office, I calculated the deed corners and found monuments set at the Northeast, Northwest and Southwest corners. These monuments were held as shown hereon. The Southwest deed corner was set on filed survey number 3183, but has been filled over with approximately 5 foot of fill. I reset said Southwest corner at the computed position. The Westerly line was marked with hubs and 3 foot wood lath at specific intervals.

**SURVEY NARRATIVE  
TO COMPLY WITH O.R.S. 209.250**

**PURPOSE:** TO SURVEY AND MONUMENT THOSE TRACTS OF LAND DESCRIBED WITHIN INSTRUMENT NO. 2004-071290 & 2006-044303 OF THE OFFICIAL RECORDS OF JACKSON COUNTY, OREGON, FOR A PROPOSED FUTURE CONDOMINIUM CONVERSION.

**PROCEDURE:** THIS SURVEY WAS CONDUCTED UTILIZING AN ELECTRONIC LEICA TCRA 1203 ROBOTIC TOTAL STATION AND RANGING PRISMS, IN CONJUNCTION WITH ASHTECH PROMARK 2 SURVEY GRADE GLOBAL POSITIONING SATELLITE RECEIVERS UTILIZED FOR ESTABLISHING A SURVEY CONTROL NETWORK FOR THIS PROJECT. THE SUBJECT PROPERTY WAS PREVIOUSLY SURVEYED BY BARRY KAISER AND FILED AS SURVEY NO. 18199 IN THE OFFICE OF THE JACKSON COUNTY SURVEYOR, WHICH FIT WELL WITH THE DEED RECORD. SINCE KAISER'S SURVEY WAS PERFORMED IN 2004, CONSTRUCTION ACTIVITIES HAVE RESULTED IN ALL OF THE MONUMENTS THAT HE SET BEING DESTROYED EXCEPT FOR THE SOUTHEAST CORNER OF SAID SURVEY. AT THE TIME OF THIS SURVEY, A MONUMENT WITH A CAP IDENTIFYING THE SURVEYOR AS CAEL NEATHAMER, WAS FOUND AT A POINT BEING THE 100.00 FOOT WESTERLY EXTENSION OF THE SOUTH LINE OF KAISER'S SURVEY. A CALL TO SURVEYOR NEATHAMER INDICATED A SURVEY WAS IN PROGRESS, BUT NO MAP HAD BEEN FILED YET AS OF TODAY. NEATHAMER'S MONUMENT FIT THE SOUTH LINE WELL PER KAISER'S RECORD BEARING AND WAS HELD FOR LINE. MONUMENTS RECOVERED ALONG LEWIS AVENUE MATCHED WITH KAISER'S SURVEY AND WERE ALSO HELD FOR LINE. THE IRON PIPE DENOTED ON KAISER'S SURVEY AND SHOWN AS 0.45 FEET WEST OF THE WEST LINE OF LEWIS AVENUE AND ALSO CALLED OUT IN THE DEED RECORD WAS HELD FOR POSITION FOR THE NORTH LINE OF THE SUBJECT PROPERTY AND HELD PARALLEL WITH THE AFOREMENTIONED MONUMENTED SOUTH LINE. THE WEST LINE OF THE SUBJECT TRACT WAS DETERMINED BY HOLDING THE DEED RECORD CALLS OF BEING PARALLEL WITH AND 250.075 FEET EAST OF THE WEST LINE OF DONATION LAND CLAIM NO. 87 AND HAVING A DEED RECORD LENGTH OF 235.00 FEET. A STREET DEDICATION RECORDED WITHIN INSTRUMENT NO. 2004-065805 TOOK A PORTION OF THE SOUTH SIDE OF THE SUBJECT PROPERTY, AS SHOWN ON THIS MAP. THE REMAINING LINES OF THE SUBJECT TRACT WERE DETERMINED BY DEED RECORD CALLS CONTAINED THEREIN OF THE AREA DESCRIBED.

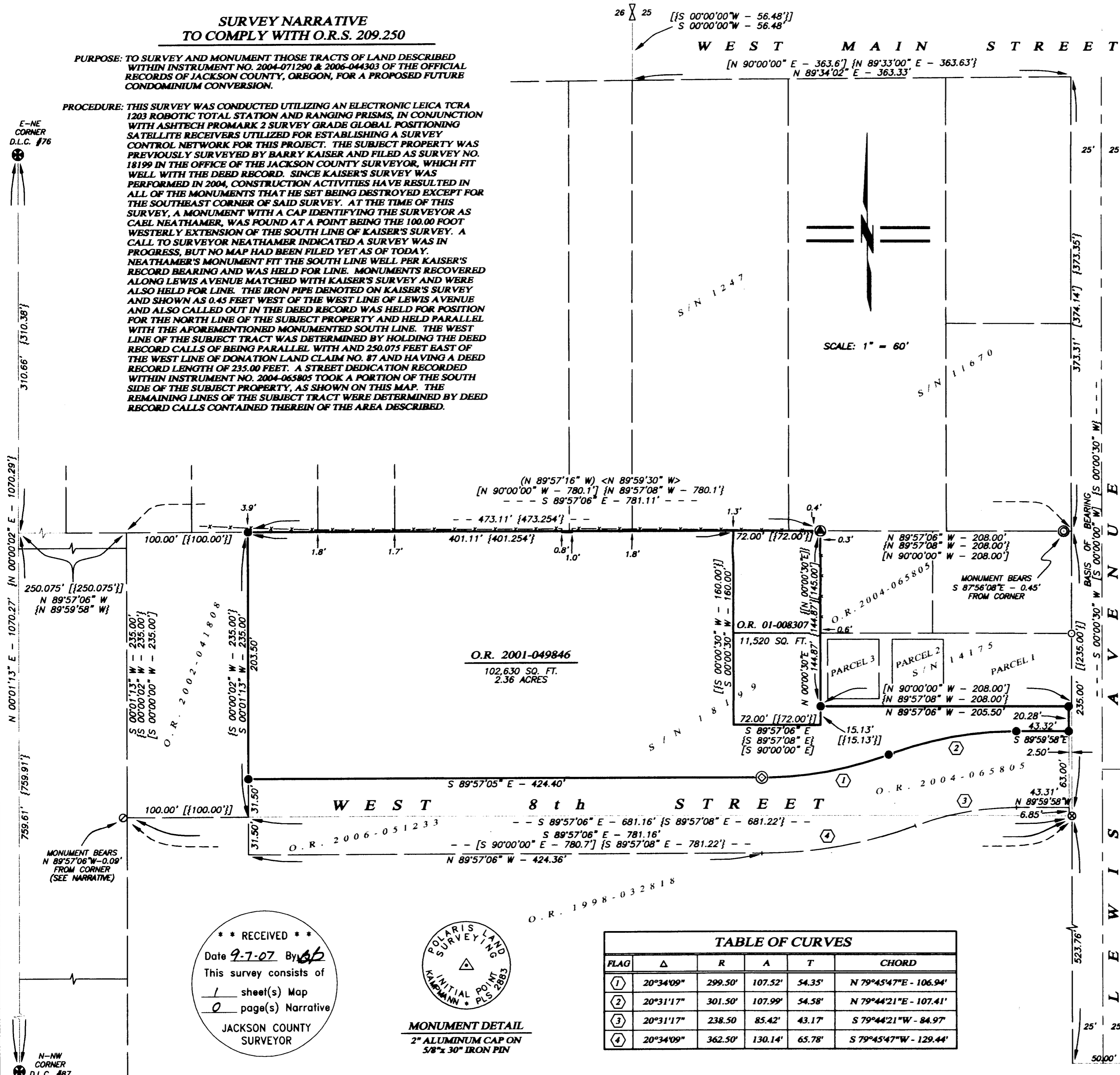

**BASIS OF BEARING**

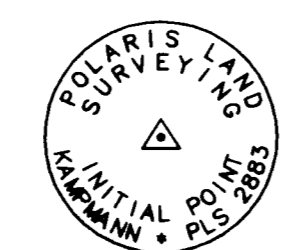
