NARRATIVE

PURPOSE: To survey and mark the corners of instrument number 69-04045 of the Official Records of Jackson County, Oregon.

PROCEDURE: I found and tied monuments found on filed survey number 5264 and right of way monuments set by Jackson County Road and Parks Department as shown on filed survey 16448. Ties between the East 1/16th corner on the South line of Section 4 and the Northeast corner of Section 4 checked very close to filed survey number 5264. I calculated the deed corners of instrument number O.R. 69-04045 and set monuments as shown.
