SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250, OREGON REVISED STATUTES

PURPOSE. Perform a boundary survey and prepare a Final Plat pursuant to Client's instructions and as approved by the Jackson County Planning Department.

PROCEDURE: Utilizing a Trimble 5600 Total Station and Trimble 5700 Global Pos-Itioning System (GPS), Trimble TSCe data collectors with Trimble Survey Controller software, all found monuments, as depicted hereon, were tied by closed loop traverse or by redundant observations. Records utilized for this survey: Instruments Numbered 02-038198, 00-017421 and 04-048594 of the Official Records of Jackson County, Oregon; Surveys Numbered 1692 and 2426, as filed in the office the Jackson County Surveyor.

The East One-sixteenth corner common to Section 32 of Township 35 South, Range I West, and Section 5 of Township 36 South, Range I West, was searched for and not found. Computed said corner utilizing the original bearing trees per said Survey Number 1692. All found monuments nórtherly álong the East One-sixteenth line were found to be off westerly due to apparent geological subsidence of the existing slope. Near the Center-East One-sixteenth corner, a 5/8-inch iron pin being exposed 0.9 foot, and leaning northwesterly was found and believed to be disturbed. Computed the original position for said Center-East One-sixteenth corner utilizing the original bearing trees per said Survey Number 1692. Utilizing the computed positions for said One-sixteenth corners, the West line of the East half of the Southeast One-quarter of Section 32 was established, as depicted hereon.

The east line was established by holding found monuments at the northeast corner of Instrument Number 00-017421, the southeast corner of Instrument Number 04-048594, and record data per SN 2426, establishing the westerly right of way of Mount Castle

Utilizing said established east and west lines described herein, established the north and south lines of the subject tract utilizing a found monument near the southwest corner thereof, record data per said Survey Number 2426 along Mount Castle Drive, and holding the record distance of 300.00 feet along the west boundary for the northwest corner thereof.
