PA#2006-01090 WITH THE CITY OF ASHLAND PLANNING DEPARTMENT.

PROCEDURE: UTILIZING AN ELECTRONIC LEICA TCRA 1203 ROBOTIC TOTAL STATION AND RANGING PRISMS, IN CONJUNCTION WITH SURVEY CONTROL PREVIOUSLY ESTABLISHED BY THIS OFFICE DURING THE PERFORMANCE OF SURVEY NO. 19824, ON FILE IN THE OFFICE OF THE JACKSON COUNTY SURVEYOR, I SURVEY THE LAND AS SHOWN. A PORTION OF THE EXTERIOR BOUNDARY OF THIS SUBDIVISION WAS PREVIOUSLY SURVEYED BY RICHARD ALSPACH, A VERY REPUTABLE SURVEYOR, AND FILED AS SURVEY NO. 18063, WHICH DETERMINED THE SOUTH LINE OF LOT 10 OF ASHLAND HOMESTEAD ASSOCIATION TRACTS BY A PROPORTIONAL METHOD OF MEASUREMENT AGAINST THE PLAT RECORD BETWEEN THE SOUTH LINES OF DONATION LAND CLAIM NO. 39 AND CLAIM NO. 43. THIS METHOD IS CONSIDERED A PROPER SURVEY PROCEDURE TO UTILIZE UNDER MOST CIRCUMSTANCES WHEN COMPUTING MISSING OF LOST LOT CORNERS BETWEEN RECOVERED ORIGINAL SUBDIVISION MONUMENTS OR OTHER EVIDENCE. IN EARLY 2004. I RETRACED THIS SAME BLOCK IN THE PERFORMANCE OF SAID SURVEY NO. 19624, PRIOR TO KNOWLEDGE OF MR. ALSPACH'S SURVEY. AND FOUND WHAT I BELIEVED TO VERY POSSIBLY BE ORIGINAL BLACK IRON PIPES AT CERTAIN LOT CORNERS FOR ASHLAND HOMESTEAD ASSOCIATION. I ELECTED TO HOLD THE PIPE MONUMENTS FOR POSITION AND UTILIZED PROPORTIONAL MEASUREMENT BETWEEN THEM TO DETERMINE OTHER INTERMEDIATE LOT CORNERS, WHICH FIT VERY WELL WITH EXISTING IMPROVEMENTS AND OLD FENCELINES. THIS DETERMINATION DIFFERED FROM MR. ALSPACH'S SOUTH LINE OF LOT 10 BY LESS THAN A FOOT. ALTHOUGH I AM RELUCTANT AND HESITATE TO SHOW ANY DISCREPANCY BETWEEN THIS SURVEY AND MR. ALSPACH'S, THE EVIDENCE OF THE BLACK IRON PIPES WHICH WERE COMMONLY USED IN THAT ERA, AND THAT THEY FIT WELL WITH LONG STANDING IMPROVEMENTS WITH OTHER PROPERTIES THAT I HAD SURVEYED ON THIS BLOCK, SWAYED MY OPINION.
