
Map of Survey

RANGE 1 EAST, WILLAMETTE MERIDIAN, JACKSON COUNTY, OREGON




NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO LOCATE AND MONUMENT THE BOUNDARIES OF LOTS 1, 2, 3, 4 AND THE WEST 1/2 OF LOT 5, BLOCK I, ROGUE RIVER VALLEY ORCHARD COMPANY TRACTS SUBDIVISION AS SHOWN. THE BASIS OF BEARINGS FOR THIS SURVEY WAS THE MEASURED LINE BETWEEN FOUND MONUMENTS AT THE SOUTHEAST AND SOUTHWEST CORNERS OF DONATION LAND CLAIM No. 45 PER JACKSON COUNTY FILED MAP OF SURVEY No. 19670.

THE FIELD WORK WAS COMPLETED IN JULY, 2008. A TOPCON GTS 3-B TOTAL STATION AND DATA COLLECTOR WITH SUPPORTING EQUIPMENT WAS USED FOR THIS SURVEY UTILIZING CONTROL SET PER SAID COUNTY SURVEY 19670. THE SUBJECT PARCEL IS DESCRIBED BY LOT AND BLOCK. A PROPORTION WAS APPLIED TO THE RECORD POSITIONS TO LOCATE THE SUBJECT BOUNDARIES. THE COURSES ALONG THE EAST AND WEST LINES OF THE SUBJECT PARCEL AS SHOWN ON COUNTY SURVEY 19670 HAVE BEEN CORRECTED TO THE CALCULATED RIGHT-OF WAY POSITION OF BUTLER LANE.
