PURPOSE: TO SURVEY A LAND PARTITION OF THAT TRACT OF LAND DESCRIBED WITHIN INSTRUMENT NO. 2005-13131 OF THE OFFICIAL RECORDS OF JACKSON COUNTY, OREGON, LYING SITUATE WITHIN THE SOUTH HALF OF SECTION 21, TOWNSHIP 36 SOUTH, RANGE 3 WEST OF THE

WILLAMETTE MERIDIAN, JACKSON COUNTY, OREGON PROCEDURE: UTILIZING AN ELECTRONIC LEICA TCRA 1103 ROBOTIC TOTAL

STATION WITH RANGING PRISMS, IN CONJUNCTION WITH ASHTECH PROMARK 2 SURVEY GRADE GLOBAL POSITIONING SATELLITE (GPS) RECEIVERS TO ESTABLISH PROJECT SURVEY CONTROL NETWORK, I SURVEY THE MONUMENTS AS SHOWN HEREON. THE SUBJECT PROPERTY IS DESCRIBED AS THE SOUTHEAST QUARTER OF SECTION 21 AND THE NORTH 246.0 FEET OF THE SOUTHEAST AND SOUTHWEST QUARTERS OF THE SOUTHWEST QUARTER OF SECTION 21, IN TOWNSHIP 36 SOUTH, RANGE 3 WEST OF THE WILLAMETTE MERIDIAN IN JACKSON COUNTY, OREGON, LYING EASTERLY OF GALLS CREEK COUNTY ROAD.
