

# SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250, OREGON REVISED STATUTES

PURPOSE: Pursuant to Client's instructions, prepare and process a Property Line Adjustment Application to a decision by the City of Medford Planning Department, Planning Action Number PLA-08-149. Based on said approval, monument the resultant Tract corners, prepare a Map of Survey and file same with Jackson County, Oregon.

PROCEDURE: Utilizing a Trimble 5-6 robotic instrument and Trimble 5700 Global Positioning System (GPS) with a Trimble TSCe data collector with Trimble software, all found monuments were tled via closed traverses or by redundant ties. Records utilized: Instruments Numbered 98-034719, 08-012334 and 08-012335 of the Official Records of Jackson County, Oregon, Fair Oaks Orchard Tracts (recorded September 15, 1910, in Volume 2 of Plats at Page 50 of the Records of Jackson County, Oregon), and Surveys Numbered 2280, 4570, 6468, 15866, 16072 and 20042 as filed in the office of the Jackson County Surveyor.


The exterior boundary for the adjusted Tracts established by this office on Survey Number 20042, filed in the office of the Jackson County Surveyor, May 27, 2007. The monuments set on said survey were recovered as shown hereon. Based on said Survey Number 20042, adjusted Tract I to contain 8 acres and transferred the remaining acreage to Tract 2.

Utilizing said control, the resultant boundaries were then computed and the corners established as depicted hereon. The first monument was established on January 21, 2009.


