

SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250, OREGON REVISED STATUTES

PURPOSE: Perform a boundary survey, recover record monuments, set monuments to mark property corners, as needed, and to prepare and file a Map of Survey in the office of the Jackson County Surveyor.

PROCEDURE: Utilizing a Trimble S6 robotic instrument and a Trimble TSC2 data collector with Trimble Survey Controller software, all found monuments were tied via closed traverses or by redundant ties. Records utilized: !nstruments Numbered 2000-021386 and 2000-042189 of the Official Records of Jackson County, Oregon; HACIENDA PARK, a plat recorded March II, 1960, in Volume 8 of Plats at Page 32 of the Records of Jackson County, Oregon; and, Surveys Numbered 10569 and 13100 as filed in the office of the Jackson County Surveyor.

Recovered monuments marking the Southwest and Southeast corners of Block I, HACIENDA PARK. From which, established the Basis of Bearings and the bearings of the east-west lines of the subject tracts hereon. Utilizing said Southeast corner of Block I, HACIENDA PARK, and a found monument per Survey Number 10569, established the westerly right of way of Church Street.

Utilizing deed distances per Instruments Numbered 2000-021386 and 2000-042189, and the found monuments described herein and depicted hereon, established the boundaries of the subject tracts of land as depicted hereon.

It should be noted that a found monument per Survey Number 13100 fell on the westerly boundary per Instrument Number 2000-021386, but 0.10 foot northerly of the northerly boundary thereof. Also, a found monument as referenced on Survey Number 10569 fell on the easterly boundary of said instrument, but northerly 0.14 foot from the southerly boundary thereof. Due to the location of said monuments in relationship to improvements surrounding them, said monuments were not held for the true corner positions.

Monuments were set at the property corner positions on May 30, 2007, as depicted hereon.

MAP OF SURVEY


