SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250, OREGON REVISED STATUTES

PURPOSE: Perform a boundary survey, and to prepare and process a Final Plat application pursuant to Client's instructions and as approved on November 17, 2008, by the Jackson County Development Services Case File number SUB2008-00058.

PROCEDURE: Utilizing Trimble 5600 and 56 Total Stations, Trimble 5700 Global Postioning System (GPS) equipment, and Trimble TSCe and Trimble TSC2 data collectors with Trimble Survey Controller software, all found monuments, as depicted hereon, were tied by closed loop traverse or by redundant observations.
