Located in the Northwest One-quarter of Section 28, and the North Half of Section 29, Township 38 South, Range 3 West of the Willamette Meridian, Jackson County, Oregon.

SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250, OREGON REVISED STATUTES

PURPOSE: Perform a limited boundary survey and prepare a Property Line Adjustment pursuant to Client's instructions.

PROCEDURE: Utilizing a Trimble S-6 robotic instrument and Trimble 5700 Global Positioning System (GPS) with a Trimble TSCe data collector with Trimble software, all found monuments were tied via closed traverses or by redundant ties. Records utilized: Instruments Numbered 2006-050229, 2008-005428, 2009-007851 and 2009-007852 of the Official Records of Jackson County, Oregon.

Established the North-South line common to Sections 29 and 28 of Township 38 South, Range 3 West of the Willamette Meridian, Jackson County, Oregon holding the found section corner common to Sections 20, 21, 28 and 29 per Jackson County re-establishment notes and the found 1/4 corner common to Sections 28 and 29 per SN 3665.


Established the East-West line common to Sections 20 and 29 of said Township and Range holding the found South 1/4 corner of Section 20 per Bureau of Land Management Cadastral Survey and said Section corner common to Sections 20, 21, 28 and 29.

Per Client's request, in agreement with the adjoining property owners, established a line 25.00 feet west of and parallel with the east line of Section 29 extending south to encompass the most southerly structure.

The resultant boundary adjustment was then computed with the adjusted acreage being calculated from original acreage per the Jackson County Assessor's Office. The corners were set on January 24, 2008 as depicted hereon.
