

THIS SURVEY WAS MADE AT THE REQUEST OF JACKSON COUNTY AND THE OREGON DEPARTMENT OF TRANSPORTATION (ODOT), IN SUPPORT OF A RESUFACING PROJECT FOR JACKSON COUNTY, OREGON, LOCATED IN WHITE CITY.

THE PURPOSE OF THIS SURVEY IS TO RE-ESTABLISH THE LOCATION OF TEN FOUND MONUMENTS DESTROYED BY ROAD CONSTRUCTION ALONG HALE WAY. UTILIZING THE CONTROL AND RECOVERED MONUMENT POSISTIONS PER FILED SURVEY NUMBER 20535, THE DESTROYED MONUMENTS WERE RESET AS DESCRIBED BELOW.

THE SURVEY EQUIPMENT CONSISTED OF ONE TRIMBLE R8 GPS RECIEVER AND ONE TRIMBLE TSC2 DATA COLLECTOR.


THIS SURVEY WAS PERFORMED ON JANUARY 15, 2010.

 * 'S 1007, 1009, 1011, 1014, 1020, 1024, 1027, 1028 AND 1029 WERE REPLACED WITH THE 3-1/4" BRASS CAP AS SEEN IN THE DETAIL BELOW. CAP IS SET FLUSH WITH SURFACE IN CONCRETE.

ALL OTHER FOUND CONCRETE NAILS WERE NOT RESET DURING THIS SURVEY, NO ORIGINAL RECORD OF THESE NAILS WAS EVER FOUND.
