

To survey and monument the SW'ly and NW'ly lines of that tract described in Doc. No. 2006-028574, ORJCO.

Recovered existing control and monumentation established by this office during Survey No. No. 16832 and 18505. The SE'ly line of the subject tract is controlled by the Nw'ly line of Vol. 13, Pg. 270. JCDR. The SW'ly and NW'ly lines are controlled by Vol. 53, Pg. 108, JCDR. The surrounding tracts also makes calls to the above two tracts as the limits of their respective ownerships. Therefore deed record distance per Vol. 53, Pg. 108, JCDR (75') was held from the most Northerly corner of Vol. 13, Pg. 270, JCDR to position the the most Northerly corner of Vol. 53, Pg. 108, JCDR. From the most Southerly corner of the subject tract, Vol. 53, Pg. 108, JCDR reads "in a Northwesterly direction 50 feet to a point 143 feet Southwesterly of the point of beginning". Therefore the deed distance of 50' was held from the most Southerly corner and 143' was held from the most Northerly corner (being the same as the point of beginning).
