AFFIDAVIT OF DEFERRED MONUMENTS

Know all persons by these presents, that I, Cael E. Neathamer, a Registered Land Surveyor in the State of Oregon (Registrant No. 56545), do hereby affirm that I have established, with proper monuments, the subdivision corners depicted as deferred monuments stated under the "POST MONUMENTATION CERTIFICATE", on Sheet 2 of the official plat of SPRING MEADOWS, PHASE 2, A PLANNED UNIT DEVELOPMENT, recorded on February 11, 2010, in Volume 36 of Plats, at Page 2 of the Records of Jackson County, Oregon, and filed as Survey Number 20602 in the office of the Jackson County Surveyor.

Exception to which described as follows:

- (1) Due to corner positions falling at the face of a concrete wall (a vertical separation feature), along the west line of Lots 21 through 23 (common with the easterly right of way of the future alignment of South State Road), established Witness Monuments (being 5/8 inch diameter iron pins, 24 inches in length, with an orange plastic cap marked "NEATHAMER SURVEYING"), as follows:
