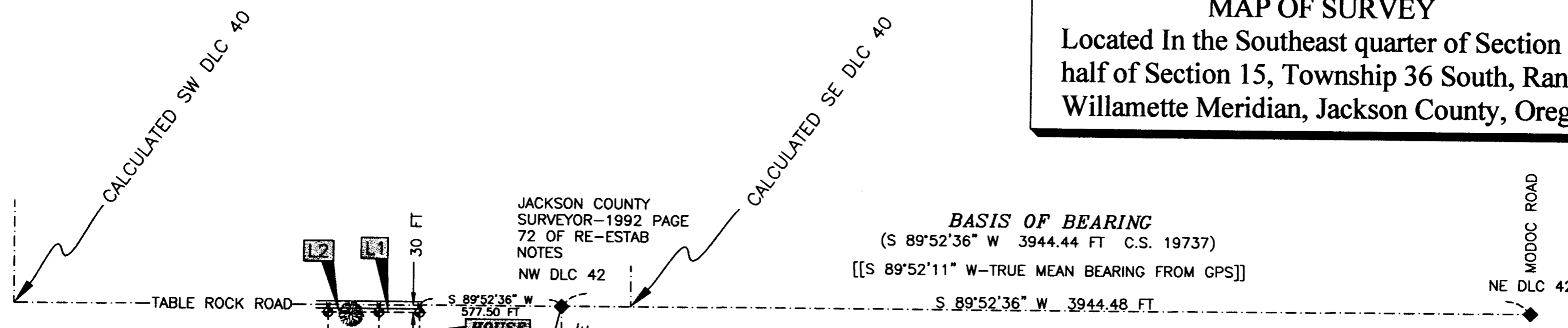


MAP OF SURVEY

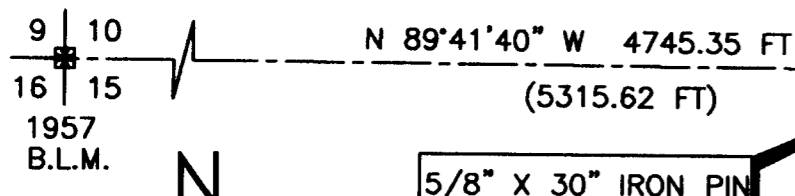

NARRATIVE TO COMPLY WITH O.R.S. 209.250

PURPOSE: TO IDENTIFY THE SAGE PROPERTY AS DESCRIBED IN DOCUMENT NO. 90-004575, JACKSON COUNTY DEED RECORDS.

HISTORY OF SURVEYS, DEED DESCRIPTIONS AND PROCEDURE: THE ORIGINAL SUBDIVISION OF THIS TOWNSHIP WAS PERFORMED BY IVES & HYDE UNDER CONTRACT NO. 39 DATED JANUARY 4, 1854. THE ORIGINAL SURVEY FOR THE SAMUEL H. SMITH DONATION LAND CLAIM NO. 40 AND THE JOHN B. WRISLEY DONATION LAND CLAIM NO. 42 WAS PERFORMED BY SEWALL TRUAX IN 1856. AN AGREED UPON LINE BETWEEN WILLIAM BYBEE AND JOSEPH SATTERFIELD (WEST OF THE SAGE PROPERTY) WAS PERFORMED BY SEWALL TRUAX ON AUGUST 18, 1856. DURING THIS SURVEY, TRUAX FOUND THE SECTION CORNER FOR SECTIONS 10, 11, 14 AND 15 AND ESTABLISHED A POINT ON THE BYBEE-SATTERFIELD LINE ALONG THE SECTION LINE FOR SECTIONS 10 AND 15- 22.30 CHAINS (1471.8 FEET) WESTERLY OF SAID SECTION CORNER. THE ORIGINAL EVIDENCE FOR THIS SECTION CORNER WAS LOST PRIOR TO 1942, AT WHICH TIME THE JACKSON COUNTY SURVEYOR SET THE EXISTING CORNER BY DOUBLE PROPORTIONATE MEASUREMENT. THE MOST RECENT COUNTY SURVEYOR REESTABLISHMENT OF THIS CORNER IS DATED FEBRUARY 17, 1981 (PAGE 31 OF REESTAB NOTES). THE CORNER FOR SECTIONS 9-10-15 AND 16 WAS REMONUMENTED FROM EVIDENCE BY THE BUREAU OF LAND MANAGEMENT IN 1957. THE MOST RECENT COUNTY SURVEYOR REESTABLISHMENT OF THIS CORNER IS DATED JUNE 11, 2008 (PAGE 113 OF REESTAB NOTES). I FOUND BOTH SECTIONS CORNERS AS DESCRIBED BY THE JACKSON COUNTY SURVEYOR'S OFFICE AND HAVE PROVIDED GPS POSITIONS AS SHOWN. THE NORTHWEST CORNER FOR DONATION LAND CLAIM NO. 42 WAS REMONUMENTED FROM EVIDENCE BY EDWARD A MCGINTY IN DECEMBER OF 1965. DURING THIS SURVEY, MCGINTY SURVEYED ALONG THE SOUTH BOUNDARY OF DONATION LAND CLAIM NO. 40 (APPROXIMATE CENTERLINE OF TABLE ROCK ROAD) AND ESTABLISHED THE BOUNDARIES OF A PARCEL WESTERLY, BUT NOT ADJACENT TO, OF MY CLIENTS PROPERTY. HAROLD L. CENTER PERFORMED A PROPERTY LINE ADJUSTMENT SURVEY FOR PARCELS LOCATED WITHIN DONATION LAND CLAIM NO. 42 ON JULY 6, 2007. REFER TO COUNTY SURVEYOR'S OFFICE RECORDED SURVEY NO. C.S. 19737. DURING THIS SURVEY, CENTER LOCATED ALL FOUR CORNERS FOR DONATION LAND CLAIM NO. 42. I HELD THE BEARING FOR THE NORTH LINE OF SAID D.L.C. AS SHOWN ON C.S. 19737 AS THE BASIS OF BEARING FOR THIS CURRENT SURVEY. THE WEST LINE OF DONATION LAND CLAIM NO. 42 IS ALSO REFERED TO AS THE EAST BOUNDARY OF THE LANDS DESCRIBED IN VOLUME 11, PAGE 12 OF THE DEED RECORDS OF JACKSON COUNTY, OREGON. THE NORTH-SOUTH LINES TO MY CLIENT'S PARCELS ARE DESCRIBED AS BEING "SOUTH TO THE ROGUE RIVER," BUT ARE INTENDED TO BE PARALLEL WITH SAID WEST LINE OF D.L.C. NO. 42. THE DESCRIPTION OF THESE PARCELS ARE FOR THE CURRENT TAX LOTS 200 AND 300. THE JACKSON COUNTY ASSESSOR CREATED TAX LOTS 1100 AND 1200 FOR TAX PURPOSES ONLY. I LOCATED THE SECTION LINE FOR SECTIONS 10 AND 15, WHICH DIVIDES THE TAX LOTS AS SHOWN. THE WITNESS POINTS AND WITNESS CORNERS AS SHOWN ARE SET ON THE TRUE PROPERTY BOUNDARIES. WITNESS POINT #1 AS SET (W.P. 1) LIES 215 FEET SOUTH OF AN IRRIGATION DITCH, AND ON THE WESTERLY EDGE OF A NORTH-SOUTH ACCESS ROAD. DEEDS OF RECORD THAT PERTAIN TO THIS SURVEY ARE: VOLUME 12, PAGE 11 DATED DECEMBER 6, 1883; VOLUME 202, PAGE 630 DATED MAY 25, 1935; VOLUME 210, PAGE 150 DATED NOVEMBER 12, 1936; VOLUME 389, PAGE 51 DATED SEPTEMBER 13, 1952; 1990-004575 DATED FEBRUARY 21, 1990; AND 1995-028892 DATED SEPTEMBER 19, 1996.
