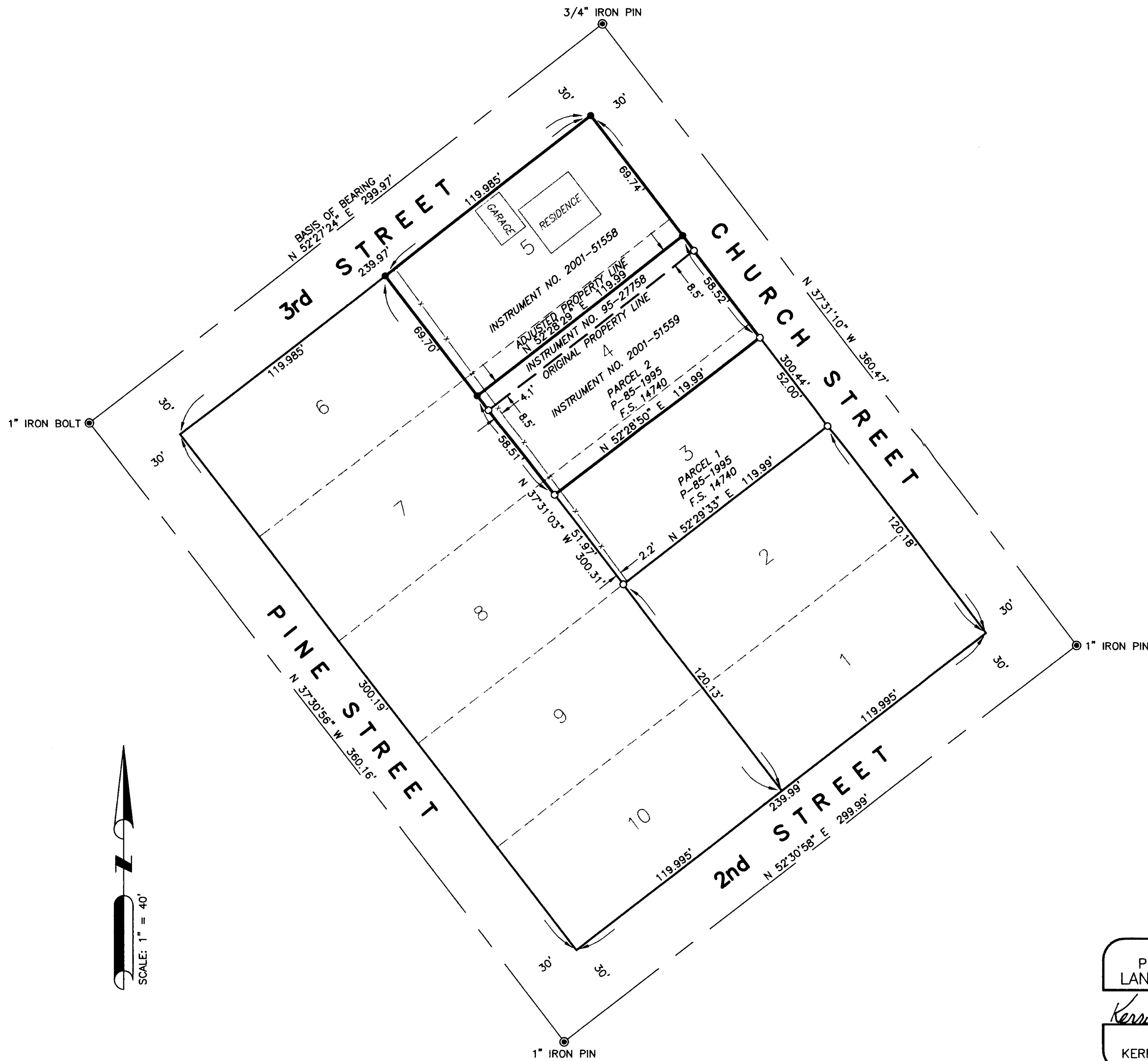


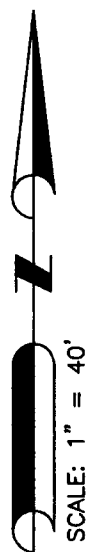
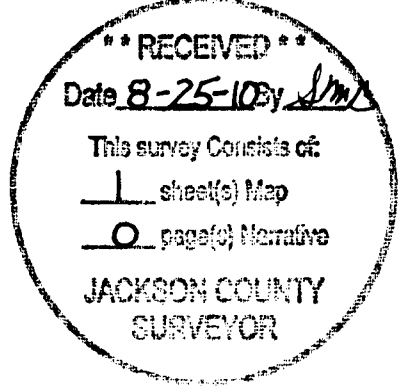
**MAP OF SURVEY**
