LOCATION: Located within the northerly portion of Lot 3, Wings Subdivision (unrecorded), in the Northeast One-quarter of the Southeast One-quarter of Section 19, Township 37 South, Range 1 West of the Willamette Meridian, in the City of Medford, Jackson County, Oregon.

<u>PURPOSE OF SURVEY</u>: Pursuant to Client's request and direction, perform a boundary survey, recover existing monuments, process an application for a Property Line Adjustment through the City of Medford (File Number PLA 11-072), establish monuments at boundary corners of resultant tracts, and to process and file a Map of Survey in the office of the Jackson County Surveyor.

SURVEY PROCEDURE: Utilizing Trimble 5700 GPS equipment with Real-time Kinematic methods utilizing the Oregon Real-time GPS Network (ORGN), a Trimble S6 Robotic Instrument and Trimble TSC2 data collectors with Trimble software, all found monuments were tied in a closed loop traverse or by redundant observations. Records utilized: Instruments Numbered 88-00969, 2010-041247 and 2011-009660 of the Official Records of Jackson County, Oregon; and, Surveys Numbered 5383, 7986, 11279 and 13551, all as filed in the office of the Jackson County Surveyor.

Utilizing said Trimble GPS equipment with the Oregon Real-time GPS Network (ORGN) and terrestrial methods, established control and tied monuments. Established the Basis of Bearings at the centerline of Wabash Avenue per Survey Number 5383 and as depicted on the accompanying map.

Utilizing found monuments and Survey Number 11279, established the centerline of Spring Street. From which, utilized Instrument Number 88-00969 and record dimensions to establish the southerly right-of-way of Spring Street and the northerly boundary of the subject tract hereon.

Utilizing found monuments, Instruments Numbered 2010-041247 and 2011-009660, and Surveys Numbered 5383 and 7986, established the southerly, easterly and westerly boundaries as depicted hereon. The easterly and westerly boundaries terminate at aforementioned southerly right-of-way of Spring Street.

Established monuments at boundary corners depicted on the accompanying map on August 1, 2011.
