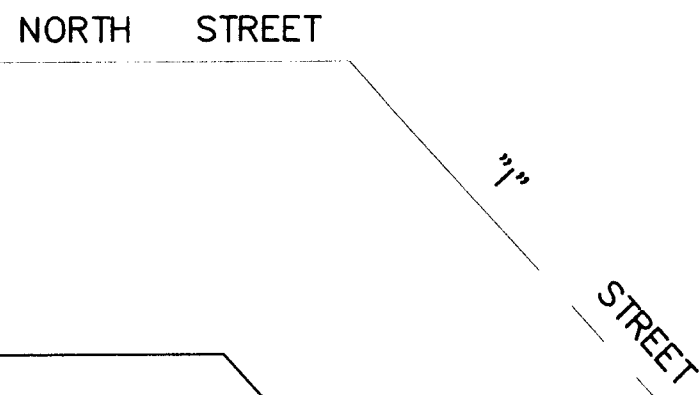
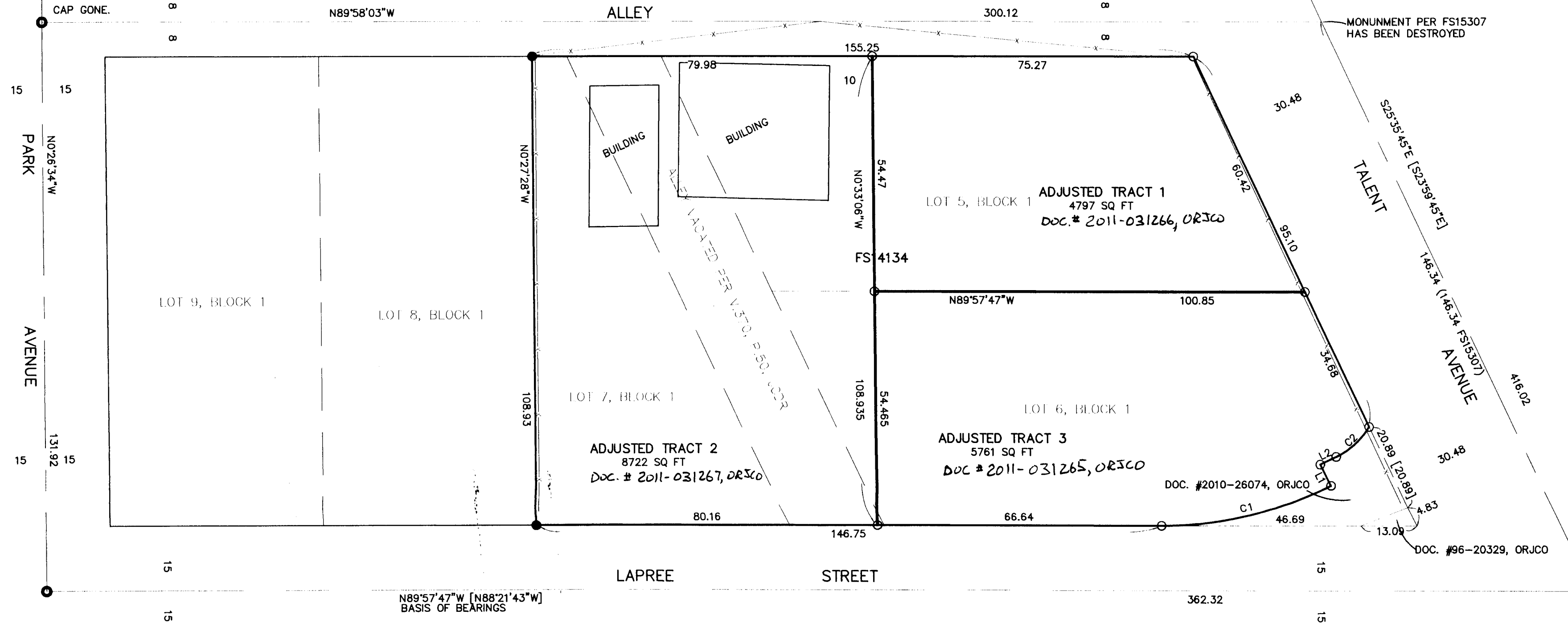

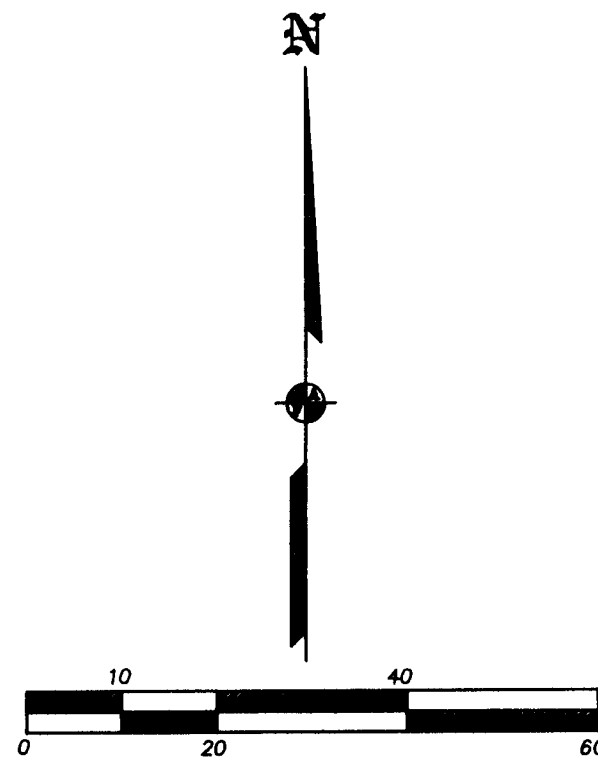
CENTERLINE OF LAPREE STREET PER FS13555 AS SHOWN HEREON.

PURPOSE: TO SURVEY AND MONUMENT THREE ADJUSTED TRACTS CREATED THROUGH A PROPERTY LINE ADJUSTMENT. SEE TALENT FILE NO. ZON-11-063.

PROCEDURE: MADE TIES TO MONUMENTS OF RECORD AS SHOWN HEREON TO CONTROL EXTERIOR AND R/W AROUND THE SUBJECT TRACT. HELD DEED RECORD ANGLES AND DISTANCES PER DOC. 2010-026074 TO COMPUTE THE NORTHERLY LINE THEREOF. SET MONUMENTS AS SHOWN HEREON ALONG THE ADJUSTED PROPERTY LINES. PREPARED LEGAL DESCRIPTIONS TO BE USED AS EXHIBITS ON DEEDS. EQUIPMENT USED IN THIS SURVEY WERE TRIMBLE R6 GPS RECEIVERS AND TOPCON GTS6000 TOTAL STATION.
