**SURVEY NARRATIVE
 TO COMPLY WITH O.R.S. 209.250**

Purpose: This survey is a retracement of S/N 6429 at the request of my client to re-establish missing corners as shown hereon.

Procedure: A search was made for the existing survey monuments established on the survey performed by Charles M Hurst in July 1976. The found monuments were tied in a closed traverse. The deed of record for this property as recorded as Instrument No 2005-32057 in the Official Records of Jackson County, Oregon, is identical to S/N 6429. Mr. Hurst noted in his narrative that there is some inconstancy with some of the previous surveys in this area. Mr. Hurst is a competent surveyor and since the deed and survey are consistent with each other I made no effort to address any of the previous issues with this survey being that it is a retracement of the original survey. My closures to Mr. Hurst survey and the deed using the found monumentation after a rotation orientated along the south boundary to my basis of bearing is noted with the record notes hereon.
