

SUBJECT PROPERTY IS JUNIOR ON THE WEST TO INSTRUMENT NO. 72-04445, ON THE SOUTH TO INSTRUMENT NO. 74-15136 AND ON THE EAST TO INSTRUMENT NO. 67-02482. THE EAST BOUNDARY OF THE SUBJECT PROPERTY WAS ESTABLISHED PRIOR TO THIS SURVEY BY S.N. 20594. SECTION 20 WAS PARTIALLY SUBDIVIDED BY S.N. 3736. USING A NIKON PL-350 TOTAL STATION A CLOSED LOOP TRAVERSE WAS COMPLETED IN THE NORTHEAST 1/4 OF SECTION 20 TO ESTABLISH CONTROL. THE NORTH EAST CORNER OF THE SUBJECT PROPERTY WAS LOCATED AT THE INTERSECTION OF THE SECTION LINE WITH THE WESTERLY RIGHT-OF-WAY LINE OF LONGBRANCH ROAD. THE RIGHT-OF-WAY LINE FOR LONGBRANCH ROAD WAS DETERMINED BY A 30' OFFSET FROM THE CENTERLINE AS CONSTRUCTED. 
