

BASIS OF BEARINGS:

Geodetic North referenced to the North American Datum 1983(91) [NAD83(91)], established by Global Positioning System Observations by this firm on Survey Number 19622, as filed in the office of the Jackson County Surveyor. Basis applied to the East Line of the Southeast One-quarter of the Southeast One-quarter of Section 19, as depicted on the accompanying map.

LOCATION:

In the Southeast and the Southwest One-quarters of Section 19, Township 39 South, Range 2 East of the Willamette Meridian, Jackson County, Oregon.

PURPOSE OF SURVEY:

Pursuant to Client's request and direction, perform a boundary survey to define the boundary corners of the original subject tracts, process a Property Line Adjustment application, establish monuments to define the boundary corners of adjusted Tract 1 and Tract 2, and to process and file a Map of Survey in the office of the Jackson County Surveyor.

SURVEY PROCEDURE:

Utilizing a Trimble S6 Robotic Total Station and a Trimble TSC2 data collector with Trimble Survey Controller software, all found monuments were tied via closed traverses or by redundant ties. Records utilized: Instruments Numbered 1991-018187, 2007-040470 (Parcel 56), 2007-052675, 2012-028156 and 2012-028157, all of the Official Records of Jackson County, Oregon; and, Surveys Numbered 9587, 13460, 19622 and 19857, as filed in the office of the Jackson County Surveyor.

Utilizing previous control established by this firm per Surveys Numbered 19622 and 19857, control, monuments and boundary resolution previously performed by this firm on Surveys Numbered 19622 and 19857, established the Basis of Bearings and the location of the Southeast One-quarter of the Southeast One-quarter of Section 19. From which, utilized the located monuments per Survey Number 13460 and Instrument Number 1991-018187 to establish the location of the South Fork Little Butte Creek Road.

Utilizing said surveys, control and resolutions, Instruments Numbered 2007-040470 (Parcel 56) and 2007-052675, Survey Number 9587 and found monuments, established the remaining boundaries of the original tracts of land. From which, utilized Instruments Numbered 2012-028156 and 2012-028157 to establish adjusted Tract 1 and Tract 2 as depicted on the accompanying map.
