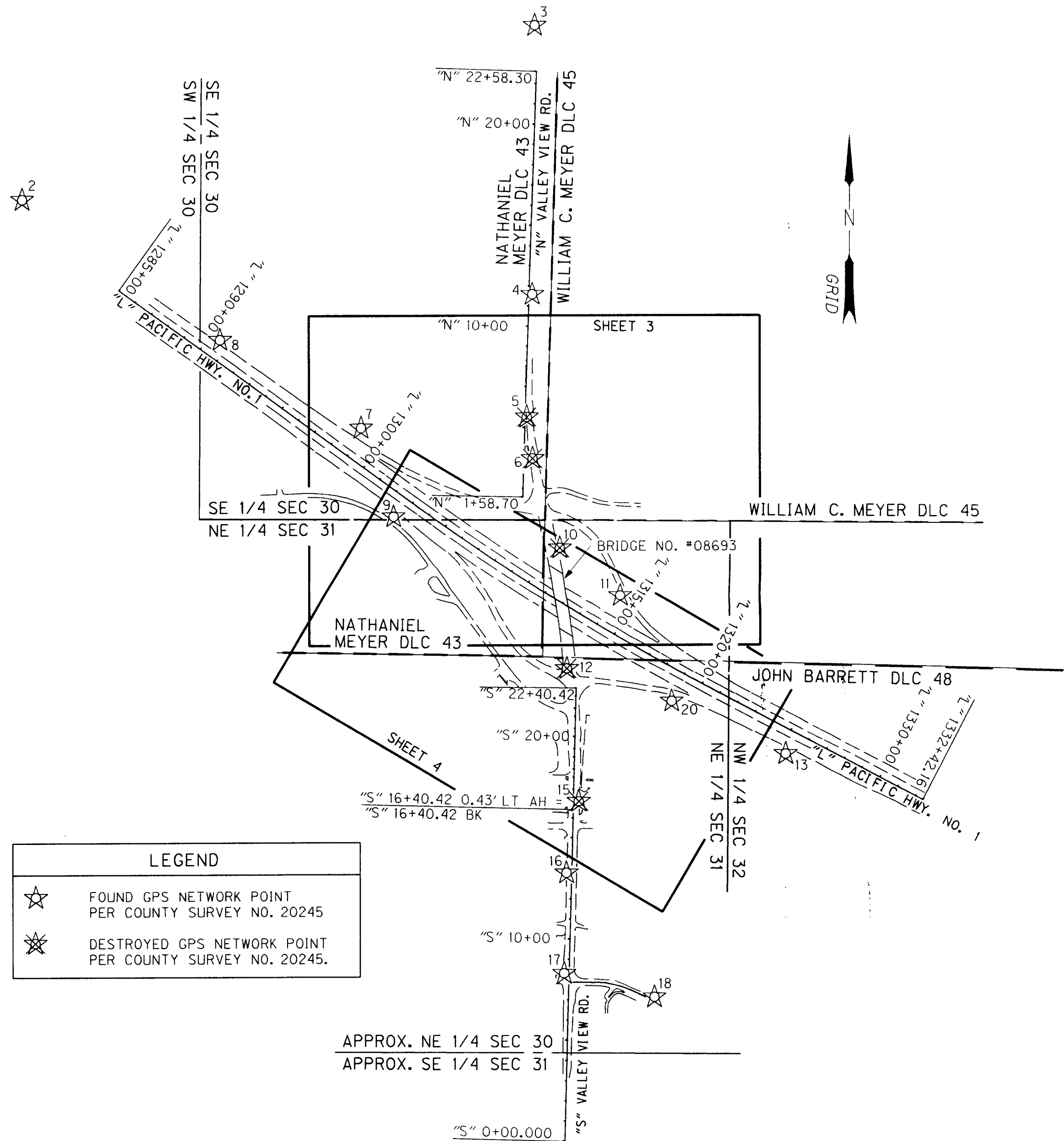

NARRATIVE TO COMPLY WITH PARAGRAPH 209.250, OREGON REVISED STATUTES

THIS SURVEY WAS MADE AT THE REQUEST OF THE OREGON DEPARTMENT OF TRANSPORTATION (ODOT), AS A POST CONSTRUCTION AND MONUMENTATION SURVEY FOR A RECENT ROADWAY IMPROVEMENT PROJECT, KNOWN AS NORTH ASHLAND INTERCHANGE VALLEY VIEW RD. CONN. #1 OVER HWY 1 (INTERSTATE 5), BUNDLE 314-S, BRIDGE NUMBER 08693.

THE PURPOSE OF THIS SURVEY IS TO MONUMENT THE RIGHT-OF-WAY ACQUIRED BY THE STATE OF OREGON IN INSTRUMENT NUMBER 2010-017603 OF THE OFFICIAL RECORDS OF JACKSON COUNTY, OREGON AND AS SHOWN ON ROLL MAP NUMBER IR-3-1760. AS A PART OF THIS SURVEY, A POST CONSTRUCTION INVENTORY OF THE CONDITION OF THE ORIGINAL MONUMENTS AND CONTROL PER COUNTY SURVEY NUMBER 20245 WITHIN THE IMPACT OF THE CONSTRUCTION ZONE FOR THE PROJECT WAS COMPLETED AS SHOWN HEREON.

THE CENTERLINE ALIGNMENT, REFERED TO AS PACIFIC HIGHWAY, IN SAID INSTRUMENT NUMBER 2010-017603, SHOWN ON SAID ROLL MAP NUMBER IR-3-1760 AND AS RESOLVED ON COUNTY SURVEY NUMBER 20245 ARE IDENTICAL. CONTROL POINTS PER SAID COUNTY SURVEY NUMBER 20245 WERE RECOVERED AND THEIR RECORD LDP COORDINATES WERE HELD. MONUMENTS WERE THEN SET AT THE RECORD STATIONS, OFFSETS AND WIDTHS OR IN THE CASE OF MONUMENT POINT NUMBER 5003 ALONG THE COMPUTED TANGENT PER SAID INSTRUMENT NUMBER 2010-017603 AND SAID ROLL MAP NUMBER IR-3-1760 AS SHOWN HEREON.

THE SOUTHWEST CORNER OF DONATION LAND CLAIM NUMBER 45 ORIGINALLY TIED AS POINT NUMBER 1020 PER COUNTY SURVEY NUMBER 20245 WAS DESTROYED DURING CONSTRUCTION AND RESET BY THE COUNTY SURVEYORS OFFICE IN 2012. THE MONUMENT WAS RE-TIED AS POINT NUMBER 2000 AS SHOWN HEREON. POINT NUMBER 1048 PER SAID COUNTY SURVEY NUMBER 20245 WAS ALSO DESTROYED DURING CONSTRUCTION, BUT WAS NOT RESET DURING THIS SURVEY, DUE TO THE PLACEMENT ON THE NEW RIGHT OF WAY ANGLE POINT SET AS POINT NUMBER 5001.

THIS SURVEY WAS PERFORMED IN JULY THROUGH AUGUST OF 2012. THE SURVEY EQUIPMENT CONSISTED OF ONE TRIMBLE R8 GPS RECEIVER, ONE TRIMBLE S6 ROBOTIC TOTAL STATION AND ONE TRIMBLE TSC2 DATA COLLECTOR.
