The Southwest Quarter of Section 11, Township 35 South, Range 4

West, Willamette Meridian, Jackson County, Oregon.


PURPOSE:

To survey and monument a Property Line Adjustment of those tracts of land described within Instrument No. 2012-026021 of the Official

Records of Jackson County, Oregon.

PROCEDURE:

Utilizing an electronic Leica TCRP 1203 robotic total station with ranging prisms and a Leica 1200 Smart Station Global Navigation Satellite System (GNSS) survey grade receiver, I survey the lands as shown. The subject property consists of six parcels described within Instrument No. 89-21038 of said Official Records that were created out of the original May Ellis parent tract described within Instrument No. 78-00958. A number of surveys were previously conducted over these lands by Loyd Moffit in the 1980's and this survey represents a retracement of those surveys, as well as of remainder Tract "F" surveyed by Ken Hoffine in Survey No. 19542. Monuments were recovered from Moffit's Survey No.'s 5332, 7347, 9496 & 9738 and found to fit well with the survey records and therefore held for position. The north line of Tract "C" shown hereon, is called out in the deed records as being the west half of the Southwest Quarter of the Southwest Quarter of Section 11 lying southerly of Evans Creek. Because of the medium high water level encountered at the time of this survey, it was not practical to locate the equidistant median point at the low water stage, therefore the location of the thread of the river is approximate only. The location of Covered Bridge Road was determined by holding the recovered spike at the centerline P.I. and monuments recovered along the southeasterly rightof-way as established by Moffit on Survey No. 9496. The next curve to the southwest was determined by holding the monument recovered from Survey No. 10161 on the north right-of-way line and fit satisfactory with the existing travelled road centerline.



BASIS OF BEARING: The Basis of Bearing for this survey is the west line of the Southwest

Quarter of the Southwest Quarter of Section 11 in Township 35 South, Range 4 West of the Willamette Meridian, having a record plat bearing of North 00°08'00" West, as referenced on Survey No. 5332 on file in the

office of the Jackson County Surveyor.
