NARRATIVE:

PURPOSE: To partition the subject property described in deed recorded as Doc. No. 2010-004950 O.R. into two parcels as tentatively approved by planning action File No. SUB 2012-00043.

PROCEDURE: Using CS 3682, 20245, and 21133 as a basis for control, completed a closed traverse acquiring survey data necessary to complete the analysis and boundary resolution for the subject property. SOUTH VALLEY VIEW ROAD: Used survey data from CS 17227 and 20245 along with Document Nos. 00-38227 & 00-38696

O.R. to determine the east boundary of Parcel No. 2. The monuments along the west right of way line were held as shown. C/L TALENT IRRIGATION'S DISTRICT CANAL: Used CS 3682 as a basis for the mathematical canal location based on found monumentation along said canal.

NORTH BOUNDARY: Held the NW cor DLC 48 and the found 1/2" rebar on the right of way line of Lowe Road as the north boundary of the subject property.
