SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

PURPOSE: TO SURVEY AND MONUMENT THAT TRACT OF LAND DESCRIBED IN DOCUMENT NO. 2013-018326 OF THE OFFICIAL RECORDS IN JACKSON COUNTY, OREGON.

PROCEDURE: UTILIZING A LEICA TCRP 1203 ROBOTIC TOTAL STATION AND RANGING PRISMS, IN CONJUNCTION WITH A LEICA 1200 SMART ROVER GNSS RECIEVER OPERATING ON THE OREGON DEPARTMENT OF TRANSPORTATION O.R.G.N. NETWORK, I ON THE OREGON DEPARTMENT OF TRANSPORTATION O.R.G.N. NETWORK, I SURVEY THE LAND AS SHOWN ON THIS PLAT. MONUMENTS RECOVERED FROM SURVEY NO.'s 1816 (1961) AND 6265 (1976) PERFORMED BY MARK BOYDEN AND FILED IN THE OFFICE OF THE JACKSON COUNTY SURVEYOR, WERE FOUND IN RESPECTABLE RELATIONSHIP WITH THE SURVEY RECORD AND HELD FOR POSITION, WHICH ESTABLISHED THE NORTH, WEST AND SOUTH LINES OF THE FROM THE HONTH LINE OF THE WEST AND SOUTH LINES OF THE SUBJECT PROPERTY. THE SOUTHEAST CORNER OF SAID SUBJECT PROPERTY WAS ESTABLISHED PER DEED RECORD DISTANCE OF 328.00 FEET WESTERLY FROM THE EAST LINE OF THE WEST HALF OF DONATION LAND CLAIM NO. 49, ALONG THE NORTH LINE OF SURVEY NO. 6265. THE NORTHEAST CORNER OF SAID PROPERTY WAS ESTABLISHED BY HOLDING THE 2.27 FOOT DEED CALL FROM THE MONUMENT RECOVERED AT A POINT OF TANGENCY ON THE SOUTHERLY LINE OF DARK HOLLOW ROAD, PER INSTRUMENT NO.2010-004376, BEING THE SENIOR TITLE OF THE ORIGINAL PARENT TRACT OF BOTH ADJACENT PARCELS.

BASIS OF BEARING

THE BASIS OF BEARING FOR THIS SURVEY IS THE EAST LINE OF THE WEST HALF OF DONATION LAND CLAIM NO. 49 IN TOWNSHIP 38 SOUTH, RANGE 2 WEST OF THE WILLAMETTE MERIDIAN, HAVING A RECORD PLAT BEARING OF NORTH 00°01'50" WEST, AS REFERENCED ON SURVEY NO. 1816, ON FILE IN THE OFFICE OF THE JACKSON COUNTY SURVEYOR.
