SURVEY NARRATIVE

PURPOSE: To survey and monument Lots 1,2,3 and 4, Block 30 of "MEDCO ADDITION TO BUTTE FALLS, OREGON" as filed in Volume 6, Page 31 of the records of Jackson County, Oregon.

PROCEDURE: Ties were made to the 1" iron rod set at the intersection with the West line of said Subdivision and Butte Falls Corporation line, the found 1" iron pipe at the Southwest corner of said subdivision, the found 3/4" iron pipe at the Southeast corner of said subdivision, the 1" iron pipe on the East line of said subdivision and the found $1\frac{1}{4}$ " iron pipe at the Northwest corner of Lot 4, Block 31. I then computed and set monuments at the corners of Lot 4, Block 30 as shown hereon. It is to be noted that there are un-recorded found monuments throughout this subdivision. Ties were made to the monuments found.
