SURVEY NARRATIVE

Purpose: This survey was conducted to mark the lines per Hancock Forest Management Inc. standards.

Procedure: This survey was conducted using Trimble GPS 5800 and R-8 receivers and Trimble 5600 robotic total station. We searched for a couple of days for the northwest corner which was found damaged after we proportioned in a corner 37 feet westerly of the found position. The proportioned position was obliterated following the discovery of the original corner and supporting stump BT. Following discussion with the County Surveyor it was decided that they would do a proper re-establishment for this corner. All other corners relied on to mark lines are per record re-establishment notes on file with the County Surveyors office. The 1/4 corners between sections 10-11 and 12-13 were searched for and not found at the probable stubbed positions. All solid lines on this survey were marked. No monuments were set on this survey.

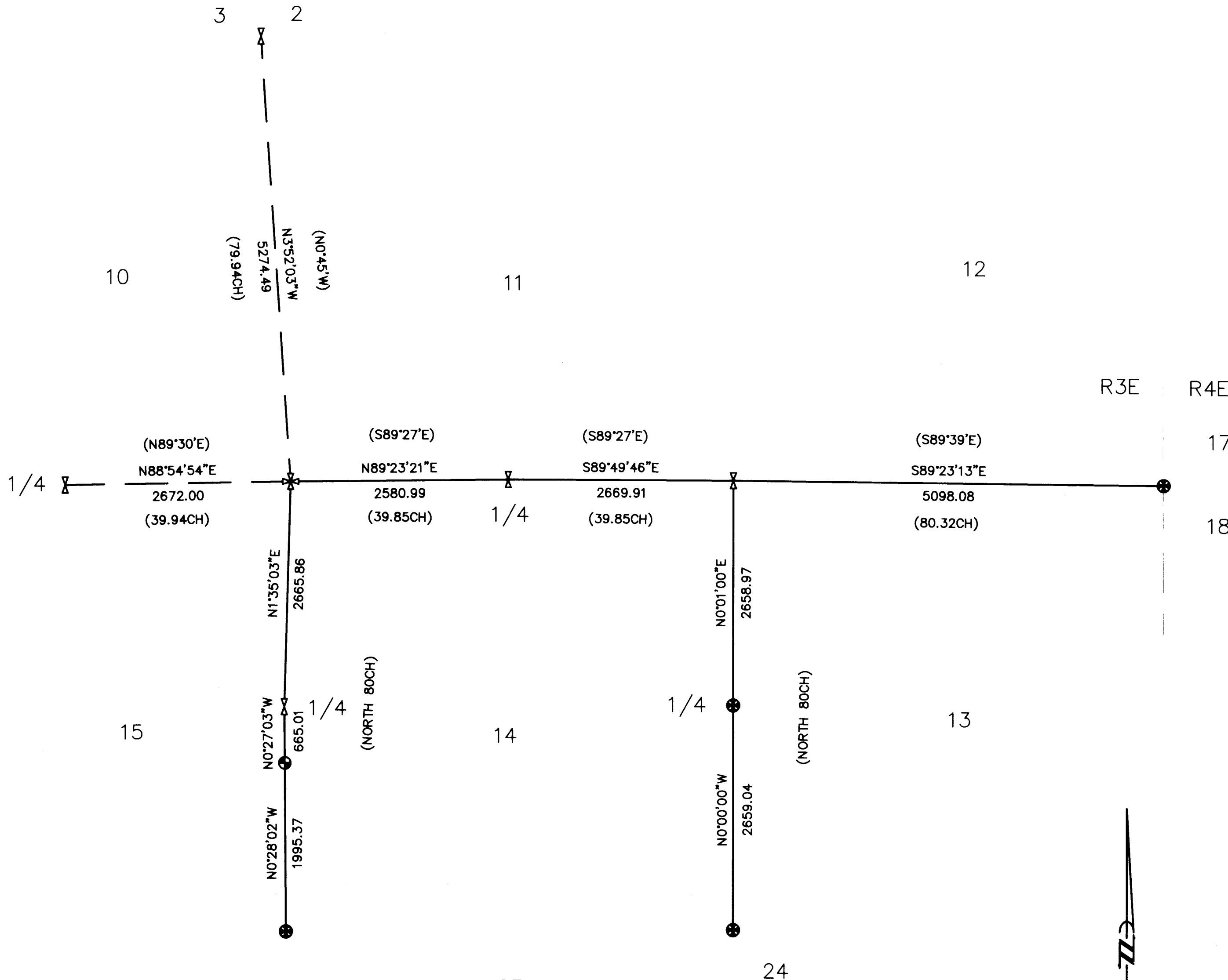

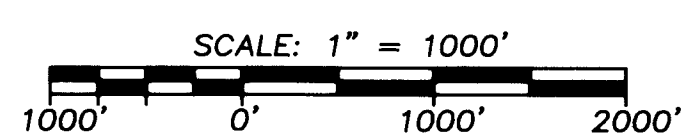
