**FURPOSE:** Pursuant to Clients instructions, perform a boundary survey consisting of recovering or establishing monuments at corners of the exterior boundaries of the subject tracts of land, and to process and file a Map of Survey in the office of the Jackson County Surveyor.

PROCEDURE: Records utilized: Instruments Numbered 2013-004648 and 2013-007935, of the Official Records of Jackson County, Oregon; and, Surveys Numbered 1269, 1272, 1276, 11224, 11793 and 12275, as filed in the office of the Jackson County Surveyor. Equipment/Software utilized: Trimble 5700 GPS equipment, Trimble S6 robotic instrument and a Trimble TSC2 data collector with Trimble Survey Controller software.

From which, utilized classical terrestrial methods, said Trimble 56 and Trimble TSC2 to establish secondary control and tie remainder of found monuments and perform topographic locations as needed.

Utilizing said found monuments and Surveys Numbered 1272, 11224 and 11793, established the centerline and right-of-way of Blackwell Road. Determined the north line of Donation Land Claim 51 from récovered monuments as depicted hereon. Based on said established rights-of-way, found monuments and the referenced records, determined the exterior boundary as depicted hereon.




