
MAP OF SURVEY


SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250, OREGON REVISED STATUTES

PURPOSE: Pursuant to Client's request and direction, perform a boundary survey, recover existing monuments, establish monuments at boundary corners as needed for fencing purposes between Lots 7 and 8 of Woodbridge Estates Subdivision, and file a Map of Survey in the office of the Jackson County Surveyor.

PROCEDURE: Utilizing a Trimble S6 Robotic Total Station and Trimble TSC2 Data Collectors with Trimble Survey Controller software, all found monuments were tied within closed loop traverses or via redundant ties. Records utilized for this survey: Instrument Numbered 2012-010484 of the Official Records of Jackson County, Oregon; and Survey Number 12168, as filed in the office of the Jackson County Surveyor.

Utilizing found monuments and said survey number, established the centerline of Woodbridge Drive. Utilizing found monuments, said survey number and said instrument number, established the exterior boundary as depicted hereon.

Established monuments at the northeast and northwest corner for Lot 8 of said subdivion, as depicted hereon on December 6, 2013.
