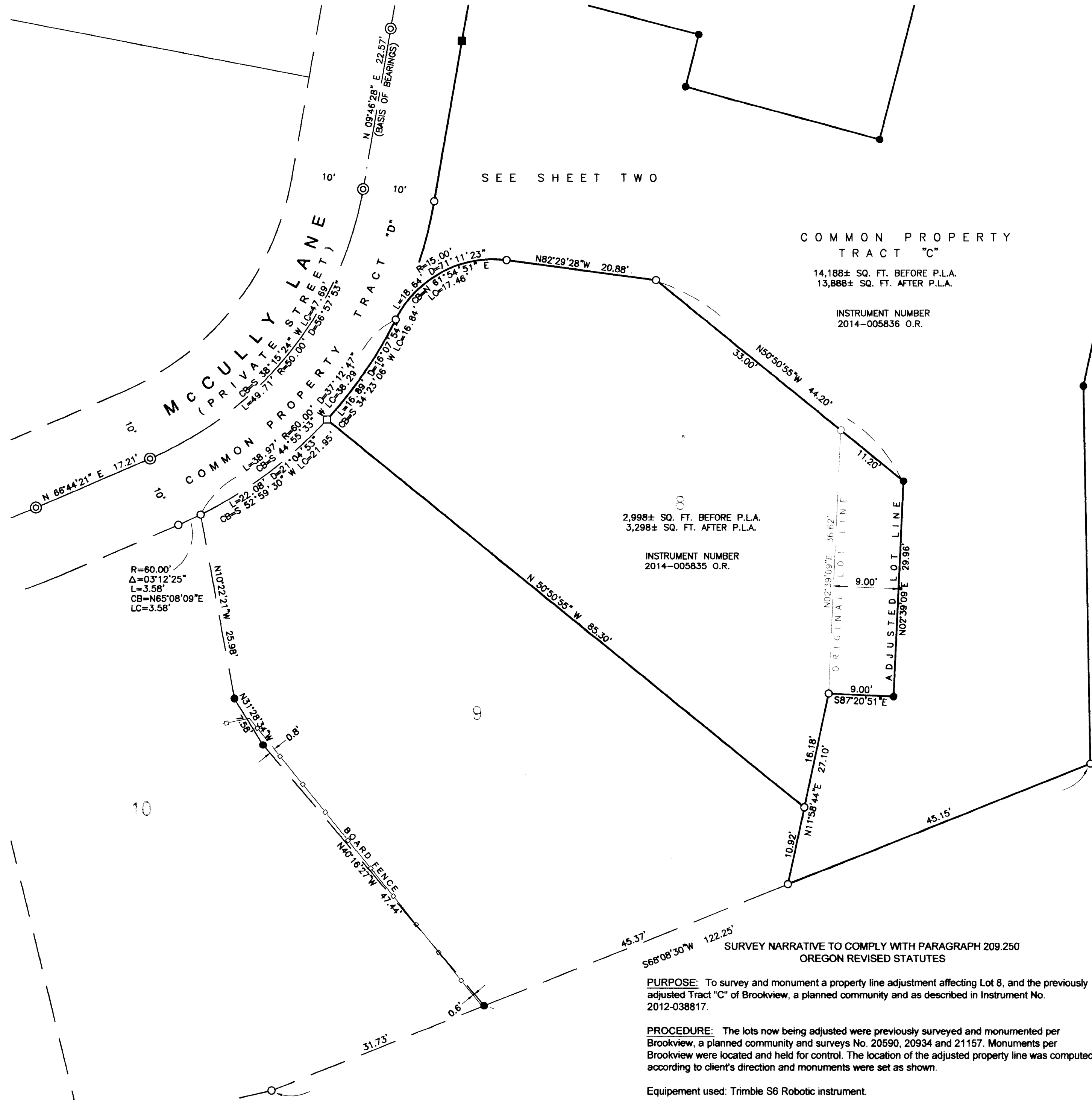

JACKSON COUNTY, OREGON

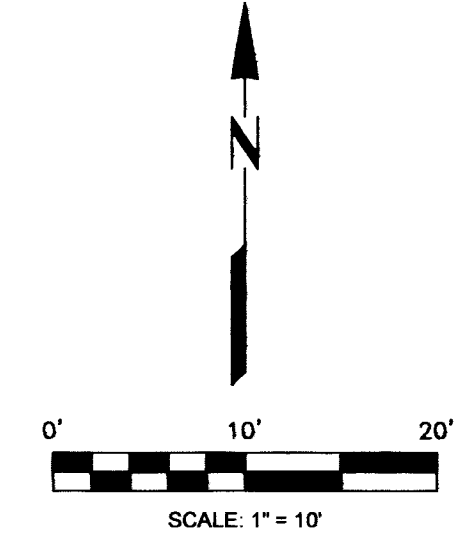

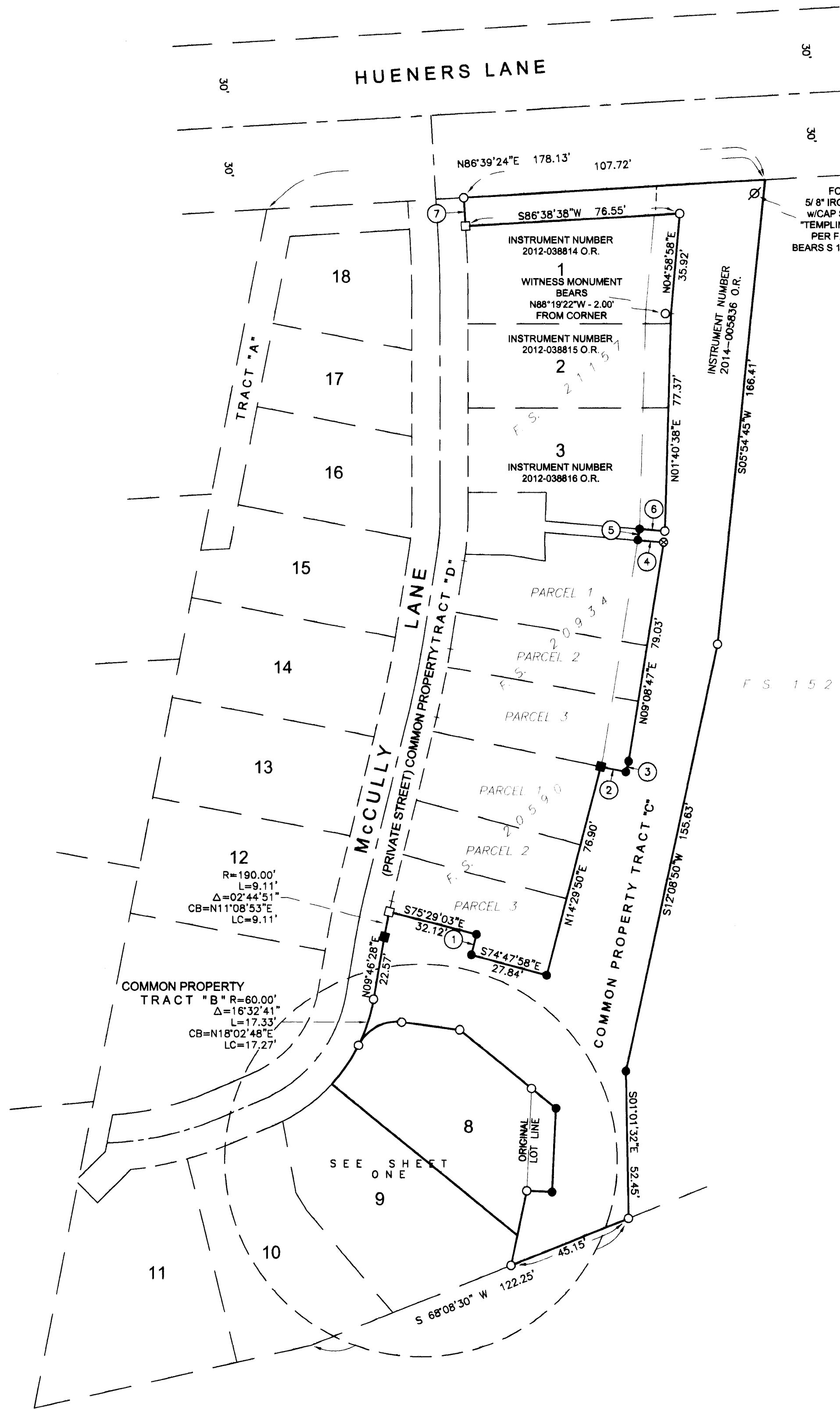

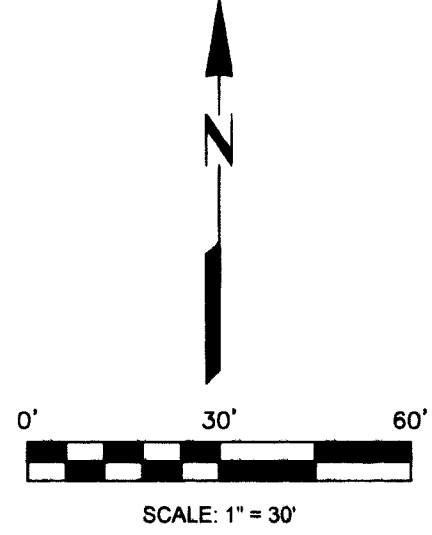
