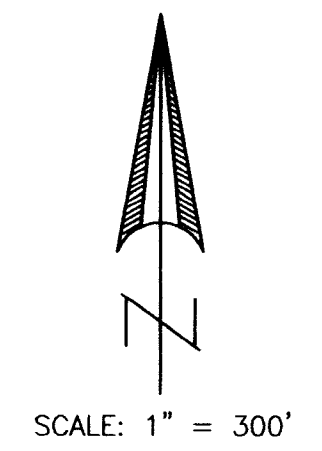
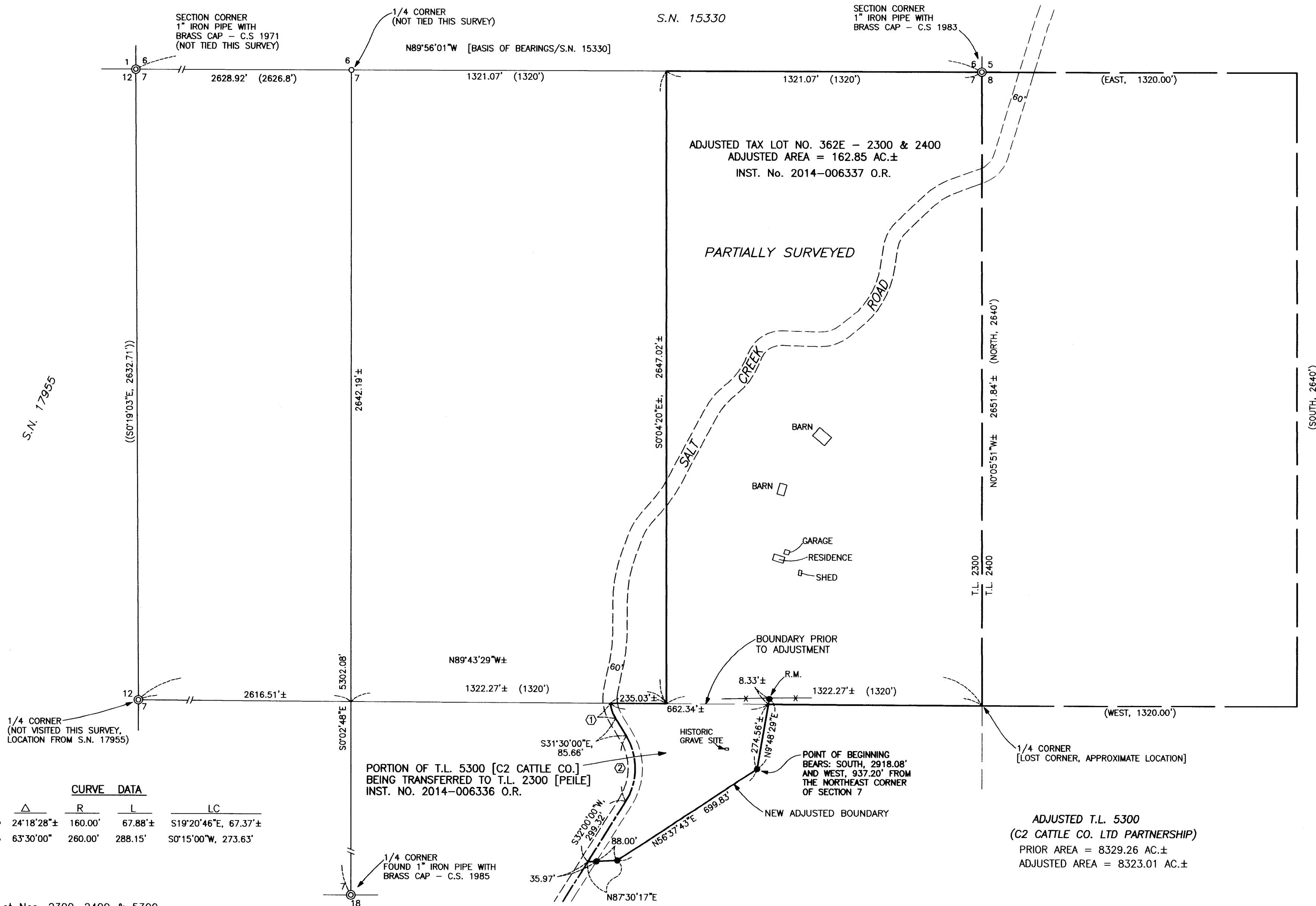
SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

PURPOSE: Property-Line-Adjustment survey adjusting the common boundary between tract described Volume 359, Page 189 D.R. (Tax Lot 5300) and tract described in Volume 58, Page 201 D.R. (Tax Lot 2300 & 2400). Also prepared description of Adjusted Tax Lot Nos. 2300 & 2400 and the portion of Tax Lot No. 5300 being transferred to Tax Lot Nos 2300 & 2400.

PROCEDURE: Equipment used on survey was a Nikon DTM530 total station. The boundaries of the subject properties were located from deeds of record and information on Filed Survey Nos. 15330 and 17955 and field ties made to found Government corners. A Subdivision of a portion of Section 7 was performed on this Survey. Control from Filed Survey No. 15330, by this office, was used to get corner locations on the North boundary. The West One-Quarter corner was computed from information on said Filed Survey No. 17955 and a survey tie was made to the South One-Quarter corner. The East One-Quarter corner is a lost corner, a search was made in the field for original evidence of this corner but none was found.
The Location of Salt Creek Road in the adjusted area was located from survey ties made to the existing traveled centerline.
Monuments were set on the adjusted boundary as shown hereon. The New Adjusted boundary was located per the clients direction and the County Approval.
