

NARRATIVE

PURPOSE: To survey and monument the North half of Instrument number 2010-43066 and the deed corners of Instrument number 97-27608 of the Official Records of Jackson County, Oregon.

PROCEDURE: In 1996 this office performed filed survey number 15005, at which time the East line of Donation Land Claim number 67 was surveyed and established. From control found from filed survey number 15005 and monuments set on filed survey number 15704, I computed and set the deed corners of the North Half of Instrument number 2010-43066 and Instrument number 97-27608 as shown. Improvement encroachments were tied and shown hereon.


This survey was performed with a Trimble R8 GPS receiver and a Nikon 531 Total Station.
