AFFIDAVIT OF CORRECTION

I, Shawn Kampmann, Professional Land Surveyor No. 2883, being duly sworn, depose and say that I am the surveyor of record for that Map of Survey filed on July 17, 2014 as Survey No. 21518 in the office of the Jackson County Surveyor.

The following correction and clarification to the Map of Survey is as follows:

- Add the label "Witness Corner" next to the monument set on the easterly line for Hooper Springs County Wayside to witness the southeast corner of the subject property at the intersection with the true south line of the Northeast Quarter of the Northeast Quarter of Section 25, which was not determined by this survey.
- 2. An omission of the word "approximate" is to be inserted on the eighth line from the bottom in the Survey Narrative and corrected to read "...database for the approximate Northeast 1/16th corner of Section 25...."
- The second from the last sentence of the Survey Narrative, beginning on the fifth line from the bottom of said Narrative is deleted and corrected to read "for the 1/16th corner and utilized as a graphic representation only for the approximate south property line, which was not determined by the survey. The bearing and distance S 89°23'07" W-780.62' along said line is shown for closure purposes only."
- The area shown for the subject property is corrected to read "21.26 acres +/-".
