SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250, OREGON REVISED STATUTES

PURPOSE: To survey and monument Client's property pursuant to the Tentative Partition Plat as conditionally approved by the City of Jacksonville's Planning Department (File No. 2012-58).

PROCEDURE: Utilizing a Trimble S-6 robot instrument and Trimble 5700 Global Positioning System (GPS) with Trimble data collectors with Trimble software, all found monuments, as depicted hereon, were tied in a closed loop traverse or by redundant observations.
