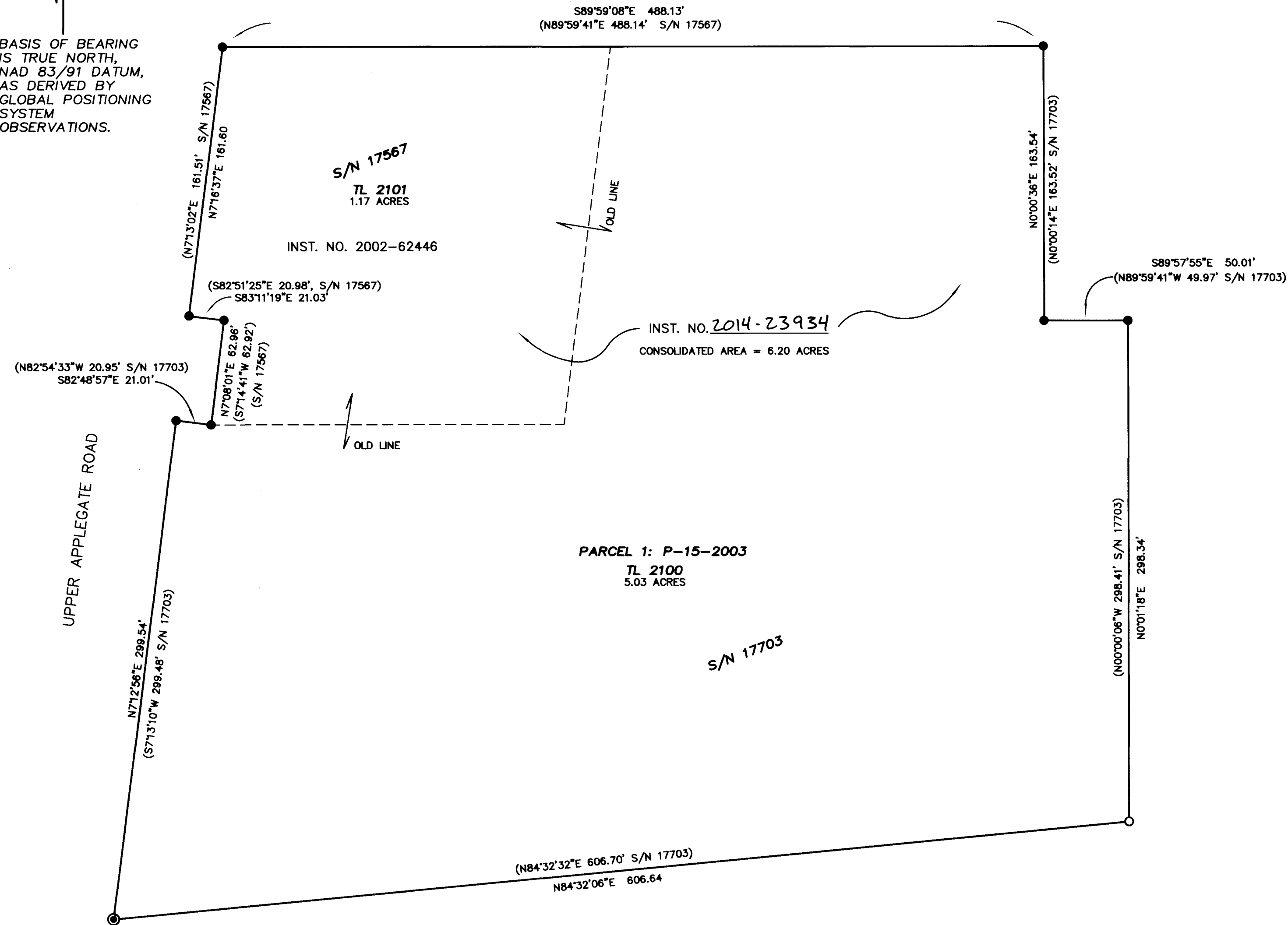
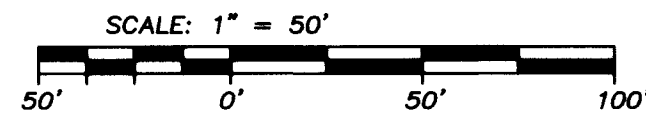

**SURVEY NARRATIVE  
TO COMPLY WITH O.R.S. 209.250**

Purpose:

This survey is to consolidate Parcel 1 of Partition Plat No. P-15-2003, recorded as Index Volume 14, Page 15 in the Records of Jackson County, Oregon, and having County Surveyor File No. 17703, with the land described in INST. NO. 02-62446 Recorded in the Official Records of said County and State, as approved by Jackson County Planning as File No. SUB2014-00028\_PLA.

Procedure:

A careful review of the original surveys of the consolidated properties reflects that the exterior boundary was established between 1971 and 2003 by S/N 4553, S/N 17567 and S/N 17703. Monuments shown hereon are a retracement of those boundaries and were tied by Trimble GPS survey grade receivers or Trimble robotic total station.
