Lots 13 & 14 of Block 4 of **GREENHILLS ESTATES, UNIT NO. 1** in the Northeast one-quarter (1/4) of Section 17, Township 37 South, Range 1 West, Willamette Meridian, City of Medford, Jackson County, Oregon.

Purpose:

To survey, monument and record a Map of Survey for a Property Line Adjustment. (City of Medford Planning File No. PLA-14-095).

Procedure:

The centerline of Beverly Drive was re-established by City of Medford reference monuments and compared favorably with the reestablishment from Survey No. 21544. A search was conducted for original monuments of Lots 13 and 14 of Block 4 of **GREENHILLS ESTATES**, **UNIT NO. 1** and produced similar results to Survey No. 21544. I additionally found the mag nail and brass tag from Survey No. 21544 and a monument at the Southeast corner of Lot 13. As the fence corner occupies the record position of the Southeast corner and the found monument is leaning, I cannot attest to the monuments original location.


