Purpose: This survey was conducted to fulfill the conditions of approval for this partition as outlined by the City of Medford in File No LDP-14-068 and the laws of the state.

Procedure: The monuments shown as found hereon were tied for this survey by this office with Trimble GPS and Robotic Instruments. The South boundary was established using the three found monuments; two from S/N 18948 and one from S/N 1778. The East boundary was established by using the found centerline monuments of Orchard Home Drive and holding the 20 foot right of way, the found monuments for the easterly boundary are within allowable positional tolerance. The Northerly boundary ws established by running between the found monuments per S/N 2995 Westerly a distance of 265.09 feet then Northerly using the found monuments per S/N 2995 for alignment, and a distance of 70.38 feet to the Northerly boundary of the tract described in Inst.
