

SE. TO SURVEY AND MONUMENT A PIECE OF LAND IN RECORD

PURPOSE: TO SURVEY AND MONUMENT A PIECE OF LAND IN RECORD DOCUMENT NUMBER 2014-015559 OF THE OFFICIAL RECORDS OF JACKSON COUNTY, OREGON. FOR PURPOSE'S OF BUILDING A DEER FENCE, PER THE REQUEST OF THE CLIENT.

PROCEDURE: THIS SURVEY WAS CONDUCTED USING A LEICA TCRP 1203+ ROBOTIC TOTAL STATION, DISTANCE PRISMS AND A LEICA CS15 DATA COLLECTOR. THE BASIS OF BEARING HELD IS THE SOUTH LINE OF DONATION LAND CLAIM NO. 65 BETWEEN FOUND MONUMENTS ON THE SOUTHEAST CORNER OF DONATION LAND CLAIM NO. 65 AND THE NORTHEAST CORNER OF DONATION LAND CLAIM NO. 67 IN SECTION 35, TOWNSHIP 38 SOUTH, RANGE I WEST OF THE WILLAMETTE MERIDIAN, JACKSON COUNTY, OREGON. THE WEST PROPERTY LINE OF SAID DOCUMENT IS BOUND BY THE CENTERLINE OF THE EXISTING ROAD (RAPP LANE). THE SOUTH PROPERTY LINE OF SAID DOCUMENT IS THE MONUMENTED NORTH PROPERTY LINE AS DEFINED ON FILED SURVEY NUMBER 3412. THE EAST PROPERTY LINE ALONG THE SOUTH-WEST HALF OF RECORDED DOCUMENT NUMBER 1990-28800 IS DESCRIBED AS BEING THE "WEST PROPERTY LINE OF THE EAST 17 ACRES OF GOVERNMENT LOT 5 OF SECTION 35, TOWNSHIP 38 SOUTH, RANGE I WEST OF THE WILLAMETTE MERIDIAN IN JACKSON, COUNTY, OREGON. AN ATTEMPT WAS MADE TO FIND LOCAL CONTROL TO DETERMINE THIS PROPERTY LINE, BUT NONE WAS FOUND. AT THIS TIME, THE CLIENT DID NOT WANT TO GO THROUGH THE RIGOROUS TIME AND RESEARCH TO DETERMINE THIS PROPERTY LINE. THE CLIENT DECIDED TO USE THE EXISTING EIGHT FOOT DEER FENCE PLACED BY THE NEIGHBOR IN GOOD FAITH THAT SAID FENCE WAS PLACED ON THE TRUE PROPERTY LINE. THE SOUTH AND WEST PROPERTY LINES OF RECORD DOCUMENT NUMBER 1990-063445 WERE DETERMINED BY RECORD BEARING AND DISTANCE USING THE FOUND 3/4" IRON PIPE AT THE SOUTHEAST CORNER OF SAID RECORD DOCUMENT NUMBER 1990-063445 AS SET ON FILED SURVEY NUMBER 2094. THE WEST PROPERTY LINES OF RECORD DOCUMENT NUMBERS 1990-28800 AND 2007-050352 WAS HELD BETWEEN FOUND MONUMENTS AS SET ON FILED SURVEY NUMBER 3659.
