## SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250, OREGON REVISED STATUTES

**PURPOSE:** Perform a boundary survey and prepare a Final Plat pursuant to Client's instructions and as approved by the City of Jacksonville Planning Commission (File No. 2015-013).

I, recorded October 13, 1965, in Volume 10 of Plats at Page 18, of the Records of Jackson County, Oregon, and also filed as Survey Number 2911 in the office of the Jackson County Surveyor; Survey Number 11192, as filed in the office of the Jackson County Surveyor. Equipment/Software utilized: Trimble RIO GNSS System, Trimble TSC3 data collector with Trimble Access software, S6 Robotic instrument, Trimble Business Center and Trimble Terramodel. The basis of bearings is Geodetic North (note that the grid bearings depicted on this plat do not equal géodetic bearings due to meridian convergence).
