SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

Purpose: To survey and monument the property line adjustment approved by the City of Jacksonville Planning Department on April 14, 2015 as File No. 2015–10–Property Line Adjustment.

Procedure: Tax lot 2700 had not been previously survey in its entirety but the adjoining lots had been. Utilizing found monuments from S/N's 2857, 6586 and 18121 we established the exterior boundaries of the subject properties. Note the easterly and westerly lines of tax lot 2600 were mapped per deed record on S/N 18121 as the only line of interest at that time was the agreed to line surveyed at that time. The original survey monuments found were held as an original survey and the boundary was resolved utilizing the deeds and $ec{arkappa}$ survey information resulting in the boundary shown hereon. The new boundary as agreed to by the owners of these properties and as approved by the City was monumented as $\sqrt{3}$ shown hereon. We a set a 1 foot witness monument on line 7 between the found monuments for the southwesterly corner of tax lot 2600 because of the location of a shed. As a note a diligent search for the origin of the two found centerline monuments was conducted. We were unable to verify when the monuments were set, therefore we noted previous surveys which showed the found monuments.
