SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

Purpose: To survey and monument the property described in Inst. No 87-21094 recorded in the Official Records of Jackson County, Oregon.

Procedure: The property to the north of this site was surveyed by this office and filed as S/N 18940 and 19490. These surveys and deeds are parallel with and perpendicular to the DLC line. This solution is consistent with all other work reviewed on Dobrot Way. The south line of this site was monumented per the deed record as shown hereon. Note that both the DLC and 1/4 corner of section 34-3 now have a building at their location.
