
MAP OF SURVEY

survey. The boundaries of this tract were based on the description in Document No.93-42027 O.R.J.Co. The centerline of Eastside County Road was determined from the physical location of the exisitina asphaltic surface, no right of way monumentation was ever established other than the physical location of Eastside Road itself. F.S. 21661 established only the pavement location but it did reflect the Rights of Way for Eastside County Road. Otherwise most favorable retracement values were found relative to this survey. The said Deed description positions the Notheasterly corner of this property 1589.15 along the N-S centerline Section 15, which fit favorably with lines of occupation. The centerline of the Applegate River was checked in relation to the high water mark at the time of this survey. The closing line in the deed calls closed most favorably on the property line described in said f.s.21661. The buildings are so noted to clarify their true location along the Northerly boundary line. The elevation shown was determined from GPS observation NAVD88 geoid 12a orthometric height of 461.07 meters at finish floor elevation.


