SURVEY NARRATIVE TO COMPLY WITH O.R.S. 209.250

Purpose: To survey and monument the lot consolidation of the parcels described in Instrument No 2015—010173 as recorded in the Official Records of Jackson County, Oregon, as approved by the City of Central Point, File Number 15026, dated September 14, 2015.

Procedure: The Cooksey Addition plat record dimensions were used because they conform well with the previous surveys in the area as shown on this map. The monuments not shown hereon from previous S/N 2172, 7388 and 11005 were searched for and not found. The westerly boundary was established by offsetting the center line of South Haskell Street the record distance. The easterly boundary was established from the center line of Central Oregon and Pacific Railroad, as observed at Scenic Avenue and Beall Lane, the record distance. The southerly boundary was established utilizing the found monuments on the vacated center line of the alley as shown hereon. The resulting boundary is delineated by the solid lines on this map.
