



SURVEY NARRATIVE TO COMPLY WITH PARAGRAPH 209.250, OREGON REVISED STATUTES

FURPOSE: Pursuant to Client's request and direction, perform a boundary survey, recover existing monuments, establish monuments at boundary corners as needed, and file a Map of Survey in the office of the Jackson County Surveyor.


PROCEDURE: Utilizing a Nikon DTM-520 Total Station, a Trimble S7 Robotic Total Station, a Trimble TSC3 Data Collector with Trimble Access software, Trimble Business Center and Trimble Terramodel, all found monuments were tied within closed loop traverses or via redundant ties. Records utilized for this survey: Instrument Number 02-11131, of the Official Records of Jackson County, Oregon; Surveys Numbered 1418, 2079, 6074, 14567, and 18023, all as filed in the office of the Jackson County Surveyor; CENTRAL ADDITION to the Town of Eagle Point, filed for record on February II, 1911 in Volume 3 of Plats at Page 2 of the Records of Jackson County, Oregon and EAGLE PARK SUBDIVISION, filed for record on August 23, 1960 in Volume 8 at Page 39 of the Records of Jackson County, Oregon.

Held the found monuments along the centerline of Platt Street and applied the Basis of Bearings per Survey Number 6074. From which, established the centerlines of Kelso Street and Jason Street holding said found monuments and turning record angles from Platt Street. The intersection of Kelso Street and Ortega avenue was established by the following procedure: computed the midpoint between the two found monuments along Ortega Avenue (refer to Note "A"); from said calculated position, held the resultant bearing of the record turning angle from Kelso to Ortega, to intersect with the centerline of Kelso Street. Said centerline of Ortega Avenue was then extended to intersect the centerline of Jason Street, thus establishing the intersection of Ortega Avenue and Jason Street. The computed centerlines were then offset to establish their respective rights-of-way and Block 13 of said CENTRAL ADDITION. The monuments found along the computed southerly right-of-way of Jason Street related to said right-of-way within reasonable tolerances.

From which, utilized proportionate distances to compute the interior lots of said block, thence utilized said instrument Number to compute the remaining boundaries of the subject property.

It should be noted that the current configuration of said Block 13 is not consistent with the original plat, CENTRAL ADDITION. A search of a record map showing the current configuration was performed and resulted in not being able to find evidence of such record. However the deeds of the property are consistent with the current configuration. As such, it was concluded that the intent of the re-configuration was to create four properties equal in size. The boundary depicted hereon is reflective of this analysis.

Monuments were established, as depicted hereon, on November 17, 2015.
