



## **NARRATIVE**

## PURPOSE:

PARAMETRIX WAS CONTRACTED BY CYPRESS CREEK RENEWABLES, LLC TO RECOVER AND/OR RE-ESTABLISH ANY LOST OR OBLITERATED BOUNDARY CORNERS FOR THOSE LANDS DESCRIBED IN INSTRUMENT NO. 2011-007292, RECORDED MARCH 7, 2001, JACKSON COUNTY, OREGON OFFICIAL RECORDS.

## PROCEDURE:

WHILE RECOVERING RECORDS MONUMENTS BOTH AN ABOVE AND UNDERGROUND IRRIGATION LINE WAS OBSERVED AND LOCATED. ROGUE RIVER VALLEY IRRIGATION DISTRICT WAS CONTACTED AND WE WERE NOTIFIED THAT THIS WAS INFACT THEIR LINE AND THEY RESERVE A 15.00 FOOT EASEMENT CENTERED ON THE IRRIGATION LINE. THIS EASMENT HAS BEEN SHOWN FOR FUTURE REFERENCE.

THE WEST, EAST AND SOUTH LINES OF THE NORTHWEST QUARTER (NW1/4) OF SECTION 33 TAX LOT 300 WERE ESTABLISHED BY HOLDING FOUND MONUMENTS 1007, 1008, 1014, 1016, AS SHOWN HEREON.

THE EAST RIGHT OF WAY OF MCLAUGHLIN DRIVE WAS ESTABLISHED BY HOLDING RECORD OFFSET DISTANCES OF 36.21' ON THE SOUTH, AND 42.43' ON THE NORTH, FROM THE WEST LINE OF THE (NW1/4). THIS FIT WITH FOUND MONI IMENT 1015

THE SOUTH LINE OF THE NORTH-HALF OF THE NORTHWEST ONE-QUARTHER (N1/2, NW1/4) OF SECTION 33, WAS ESTABLISHED BY COMPLETING A QUARTER-QUARTER SECTION BREAKDOWN. THIS FIT FOR LINE WITH FOUND MONUMENT 1017. POINT 400 WAS SET AT THE INTERSECTION OF THE EAST RIGHT OF WAY OF MCLAUGHLIN DRIVE AND THE SOUTH LINE OF THE (N1/2, NW1/4) OF SECTION 33.

THE SOUTH LINE OF THE NORTH-HALF OF THE NORTH-HALF OF THE NORTHWEST ONE-QUARTHER (N1/2, N1/2, NW1/4) OF SECTION 33, ALSO BEING THE NORTH LINE OF TAX LOT 300, WAS ESTABLISHED BY COMPLETING A QUARTER-QUARTER SECTION BREAKDOWN. THIS FIT FOR LINE WITH FOUND MONUMENTS 1015 AND 1006

THE WEST LINE OF THE EAST-HALF OF THE WEST-HALF OF THE SOUTHEAST QUARTER OF THE NORTHWEST QUARTER (E1/2, W1/2, SE1/4, NW1/4), WAS ESTABLISHED BY HOLDING FOUND MONUMENT 1017 AND PROJECTING A LINE THROUGH FOUND MONUMENT 1009 TO INTERSECT WITH THE SOUTH LINE OF SAID (NW 1/4).

BASIS OF BEARINGS FOR THIS SURVEY ARE BASED ON THE OREGON COORDINATE SYSTEM (OCS) OF 1983 (2011 ADJUSTMENT), SOUTH ZONE BETWEEN THE NORTHWEST CORNER AND THE WEST QUARTER CORNER OF SECTION 33, TOWNSHIP 36 SOUTH, RANGE 1 WEST, WILLAMETTE MERIDIAN, BEING NORTH 01°11'02" EAST.
